3 **Ordinance authorizing settlement of the lawsuit filed by Crystal Gomez and Martha**
4 **Gomez against the City and County of San Francisco for \$60,000; the lawsuit was filed**
5 **on July 14, 2021, in U.S. District Court for the Northern District of California, Case No.**
6 **21-cv-05394 JCS; entitled Crystal Gomez and Martha Gomez v. City and County of San**
7 **Francisco, et al.; the lawsuit involves alleged civil rights violations.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Crystal Gomez and Martha Gomez v.
12 City and County of San Francisco, et al., U.S. District Court for the Northern District of
13 California, Case No. 21-cv-05394 JCS by the payment of \$60,000. The lawsuit involves
14 alleged civil rights violations.

15 Section 2. The above-named action was filed in U.S. District Court for the Northern
16 District of California on July 14, 2021, and the following parties were named in the lawsuit:
17 Plaintiffs: Crystal Gomez and Martha Gomez; Defendants: City and County of San Francisco,
