

1 [Traffic Regulations]

2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
4 and the San Francisco Traffic Code, the following regulations governing the movement of  
5 vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

7 Post Street, both curb lanes (eastbound and westbound), between Presidio Avenue  
8 and Steiner Street

9 **MID-BLOCK CROSSWALK - ESTABLISH**

10 Davis Street, approximately 300 feet north of Jackson Street

11 **NO TURN ON RED - ESTABLISH**

12 Market Street, eastbound, at Spear Street

13 **NO TURN ON RED, 7 AM - 7 PM, EVERYDAY - ESTABLISH**

14 3rd Street, northbound, at Folsom Street

15 **ONE-WAY STREET - RESCIND**

16 Redwood Street, eastbound, between Van Ness Avenue and Polk Street

17 **ONE-WAY STREET - ESTABLISH**

18 Redwood Street, westbound, from Van Ness Avenue to a point 33 feet west of Polk  
19 Street (retains two-way traffic from Polk Street to 33 feet westerly)

20 **NO LEFT TURN - ESTABLISH**

21 Polk Street, northbound, at Redwood Street

22 **RIGHT LANE MUST TURN RIGHT - ESTABLISH**

23 Folsom Street, eastbound, at 1st Street

1 **RIGHT TURN ONLY, EXCEPT MUNI - ESTABLISH**

2 Euclid Avenue, westbound, at Arguello Boulevard

3 **STREET CLOSURE, 10:30 AM - 2:30 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

4 Leidesdorff Street, between California and Pine Streets (for the placement of tables  
5 and chairs on the street)

6 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

7 Chestnut Street, south side, from Kearny Street to 23 feet easterly (23-foot zone)

8 ***NOTE: The following regulations on Duncan Street and Tiffany Avenue are being***  
9 ***established for a six-month trial period:***

10 **STREET CLOSURE - RESCIND**

11 Tiffany Avenue, at 29th Avenue

12 **STREET CLOSURE - ESTABLISH**

13 Tiffany Avenue, northbound direction only, at Duncan Street

14 **CROSSWALK CLOSURE - ESTABLISH**

15 Duncan Street, at Tiffany Avenue, west crosswalk (crossing Duncan Street)

16 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

17 Duncan Street, north side, from Tiffany Avenue to 40 feet westerly (40-foot zone)

18 **NO LEFT TURN - ESTABLISH**

19 Duncan Street, westbound, at Tiffany Avenue (prohibits access from Valencia  
20 Street to southbound Tiffany Avenue)

21 **RIGHT TURN ONLY - ESTABLISH**

22 Duncan Street, eastbound, at Tiffany Avenue (prohibits access from Duncan Street  
23 to Valencia Street)

Resolution enacting and rescinding traffic regulations on various streets:

**BICYCLE LANES - ESTABLISH**

Post Street, both curb lanes (eastbound and westbound), between Presidio Avenue and Steiner Street

**MID-BLOCK CROSSWALK - ESTABLISH**

Davis Street, approximately 300 feet north of Jackson Street

**NO TURN ON RED - ESTABLISH**

Market Street, eastbound, at Spear Street

**NO TURN ON RED, 7 AM - 7 PM, EVERYDAY - ESTABLISH**

3rd Street, northbound, at Folsom Street

**ONE-WAY STREET - RESCIND**

Redwood Street, eastbound, between Van Ness Avenue and Polk Street

**ONE-WAY STREET - ESTABLISH**

Redwood Street, westbound, from Van Ness Avenue to a point 33 feet west of Polk Street (retains two-way traffic from Polk Street to 33 feet westerly)

**NO LEFT TURN - ESTABLISH**

Polk Street, northbound, at Redwood Street

**RIGHT LANE MUST TURN RIGHT - ESTABLISH**

Folsom Street, eastbound, at 1st Street

**STREET CLOSURE, 10:30 AM - 2:30 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

Leidesdorff Street, between California and Pine Streets (for the placement of tables and chairs on the street)

**TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

Chestnut Street, south side, from Kearny Street to 23 feet easterly (23-foot zone)

**STREET CLOSURE - RESCIND - for a six-month trial period.**

Tiffany Avenue, at 29th Avenue

**STREET CLOSURE - ESTABLISH**

Tiffany Avenue, northbound direction only, at Duncan Street

**CROSSWALK CLOSURE - ESTABLISH**

Duncan Street, at Tiffany Avenue, west crosswalk (crossing Duncan Street)

**TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

Duncan Street, north side, from Tiffany Avenue to 40 feet westerly (40-foot zone)

**NO LEFT TURN - ESTABLISH**

Duncan Street, westbound, at Tiffany Avenue (prohibits access from Valencia Street to southbound Tiffany Avenue)

**RIGHT TURN ONLY - ESTABLISH**

Duncan Street, eastbound, at Tiffany Avenue (prohibits access from Duncan Street to Valencia Street)




