2 AMENDING CHAPTER 8 OF THE SAN FRANCISCO ADMINISTRATIVE CODE BY ADDING  
3 SECTION 16.3-7.5, ESTABLISHING A DEPARTMENT OF CONSUMER ASSURANCE,  
4 REGULATORY COMPLIANCE AND AGRICULTURAL STANDARDS AND DEFINING THE  
5 DUTIES OF THE DIRECTOR TO INCLUDE THOSE OF THE COUNTY AGRICULTURAL  
6 COMMISSIONER AND THE SEALER OF WEIGHTS AND MEASURES.

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Chapter 8 of the San Francisco Administrative Code is hereby amended by  
10 adding Section 16.3-7.5, to read as follows:

11 **SEC. 16.3-7.5. DEPARTMENT OF CONSUMER ASSURANCE, REGULATORY**  
12 **COMPLIANCE AND AGRICULTURAL STANDARDS.** There shall exist within the  
13 Department of Administrative Services a Department of Consumer Assurance, Regulatory  
14 Compliance and Agricultural Standards. The Director of said Department shall be appointed  
15 by the Director of Administrative Services and shall succeed to all of the duties of the County  
16 Agricultural Commissioner and Sealer of Weights and Measures.




