

1 [Accept and Expend Grant – HIV Evaluation Activities with High Risk, Underserved Population
2 in South Africa- \$44,043]

3 **Resolution authorizing the San Francisco Department of Public Health to retroactively**
4 **accept and expend a grant in the amount of \$44,043 from the University of California**
5 **San Francisco, to participate in a program entitled “HIV Evaluation Activities with High**
6 **Risk, Underserved Population in South Africa” for the period of September 30, 2011,**
7 **through September 29, 2012.**

9 WHEREAS, University of California San Francisco is the recipient of a grant award
10 from Centers for Disease Control and Prevention supporting the HIV Evaluation Activities with
11 High Risk, Underserved Population in South Africa; and

12 WHEREAS, With a portion of these funds, University of California San Francisco has
13 subcontracted with San Francisco Department of Public Health (DPH) in the amount of
14 \$44,043 for the period of September 30, 2011, through September 29, 2012; and,

15 WHEREAS, As a condition of receiving the grant funds, University of California San
16 Francisco requires the City to enter into an agreement (Agreement), a copy of which is on file
17 with the Clerk of the Board of Supervisors in File No. 120208; which is hereby
18 declared to be a part of this resolution as if set forth fully herein; and

19 WHEREAS, The purpose of this project will provide technical assistance and training to
20 in country partners in South Africa around size estimation methods for streetwalker and
21 injection drug users populations; and

22 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
23 partially reimburses DPH for three existing positions, one Manager VIII (Job Class No. 0943)
24 at .05 FTE, one Manager I (Job Class No. 0922) at .15 FTE, and one Epidemiologist I (Job

1 Class No. 2802) at .05 FTE for the period of September 30, 2011 through September 29,
2 2012; and,

3 WHEREAS, A request for retroactive approval is being sought because DPH did not
4 receive notification of the award until January 19, 2012 for a project start date of September
5 30, 2011; and,


6 WHEREAS, The budget includes a provision for indirect costs in the amount of \$4,719;
7 now, therefore, be it

8 RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively
9 in the amount of \$44,043 from University of California San Francisco; and, be it


10 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and


