3 **Ordinance authorizing settlement of the lawsuit filed by Rodrigo Frias Mier against the**  
4 **City and County of San Francisco for \$120,313 (City to pay Plaintiff \$85,000 and**  
5 **Department of Public Works to pay Department of Public Health \$35,313 to satisfy lien);**  
6 **the lawsuit was filed on September 30, 2020, in San Francisco Superior Court, Case No.**  
7 **CGC-20-586884; entitled Rodrigo Frias Mier; the lawsuit involves a personal injury on a**  
8 **City street.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Rodrigo Frias Mier v. City and County  
13 of San Francisco, San Francisco Superior Court, Case No. CGC-20-586884 by the payment  
14 of \$85,000 to Plaintiff and payment by DPW to DPH of \$35,313 to satisfy lien. The lawsuit  
15 involves a personal injury on a City Street.

16 Section 2. The above-named action was filed in San Francisco Superior Court on  
17 September 30, 2020, and the following parties were named in the lawsuit: Plaintiff Rodrigo  
18 Frias Mier, Defendant City and County of San Francisco.
