2 United States Department of Labor - COVID-19 National Dislocated Worker Grant - \$800,000]

3 **Resolution retroactively authorizing the Office of Economic and Workforce**
4 **Development to accept and expend a grant in the amount of \$800,000 from the**
5 **California Employment Development Department, a recipient of the grant award from**
6 **the United States Department of Labor, for the COVID-19 National Dislocated Worker**
7 **Grant during the grant period of April 10, 2020, to March 31, 2022.**

9 WHEREAS, The Administrative Code requires City departments to obtain Board of
10 Supervisors' approval to accept or expend any grant funds (Section 10.170 et seq.); and

11 WHEREAS, The United States Department of Labor released emergency Workforce
12 Innovation and Opportunity Act (WIOA) National Dislocated Worker Grants to support the
13 workforce in response to the COVID-19 pandemic and nationwide shelter-in-place orders; and

14 WHEREAS, The California Employment Development Department is a pass-through
15 entity for the United States Department of Labor; and

16 WHEREAS, The Office of Economic and Workforce Development proposed expanding
17 San Francisco's public workforce development system to respond to an additional 252
18 dislocated workers impacted by COVID-19; and

19 WHEREAS, The California Employment Development Department awarded the Office
20 of Economic and Workforce Development \$800,000 of federal WIOA funds to support
21 dislocated workers; and

22 WHEREAS, The grant does not require an Annual Salary Ordinance amendment; and

23 WHEREAS, The grant budget includes provision for indirect costs of \$80,000; now,
24 therefore, be it

1 RESOLVED, That the California Employment Development Department may fund the
2 Office of Economic and Workforce Development; and, be it

3 RESOLVED, That the Office of Economic and Workforce Development is responsible
4 for the oversight of WIOA funding for the City and County of San Francisco; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Office of
6 Economic and Workforce Development to accept and expend, on behalf of the City and
7 County of San Francisco, a grant from the California Employment Development Department
8 for WIOA National Dislocated Workers in the amount of \$800,000; and, be it

9 FURTHER RESOLVED, That the Director of the Office of Economic and Workforce
10 Development is authorized to enter into the Agreement on behalf of the City.
