The existing fleet of thirty 32-foot Orion buses in the SFMTA fleet were put into service in 2007 and are currently the oldest vehicles operating in revenue service. According to Federal Transit Administration (FTA) Circular 5010.1E, these coaches are considered small, heavy-duty transit buses and have useful lives of ten years or 350,000 miles. These vehicles reached the end of their useful lives in 2017 and the average of the fleet has reached 437,000 miles.
