**Ordinance amending the Campaign and Governmental Conduct Code to update the City's Conflict of Interest Code.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Campaign and Governmental Conduct Code is hereby amended by amending Sections 3.1-103, 3.1-105, 3.1-120, 3.1-130, 3.1-140, 3.1-145, 3.1-150, 3.1-155, 3.1-175, 3.1-195, 3.1-205, 3.1-207, 3.1-218, 3.1-225, 3.1-245, 3.1-251, 3.1-253, 3.1-275, 3.1-280, 3.1-285, 3.1-320, 3.1-335, 3.1-345, 3.1-365, 3.1-390, 3.1-410, 3.1-420, 3.1-422, 3.1-435, 3.1-445, 3.1-455, 3.1-500, 3.1-510 to read as follows:

SEC. 3.1-103. FILING OFFICERS.

Persons holding designated positions shall file the specified statements, declarations, and certificates with the filing officers designated in this Section.

4 (e) In instances where the proper filing officer for a particular, designated position is  
5 unclear, the Ethics Commission may designate the filing officer.

6 SEC. 3.1-105. NOTICE OF APPOINTMENT AND RESIGNATION.

7 (a) Every appointing authority whose appointees file statements required by  
8 Sections 3.1-101 and 3.1-102 of the Campaign and Governmental Conduct Code with the  
9 Ethics Commission shall provide written notice to the Ethics Commission of the name of any  
10 appointee who has assumed or left office or employment. Such notice shall be provided  
11 within 15 days of the City officer or employee assuming or leaving office or employment.  
12 Failure to provide such notice may constitute official misconduct.

13 (b) Whenever the Mayor or a board or commission appoints a department head, or  
14 receives the resignation or retirement notice of a department head, the official or the secretary  
15 to the board or commission who makes the appointment or receives the resignation or  
16 retirement notice, shall inform the department head of the necessity to file within 30 days of  
17 assuming office or leaving office a statement of economic interests. The official or the secretary  
18 of the board or commission who makes the appointment or receives the resignation or retirement notice  
19 shall also inform the Ethics Commission of the appointment, resignation or retirement within 15 days  
20 of the department head's assumption of or departure from office. Such written notice shall include the  
21 name of the department head, and the date on which the department was appointed, resigned or retired.  
22 Upon receiving notice of the appointment, or the resignation or retirement, of the department  
23 head, the Ethics Commission shall perform the required duties of the filing officer and obtain  
24 the required statement of economic interests.

25 SEC. 3.1-120. AIRPORT ~~COMMISSION~~.

1 (a) Disclosure Category 2. Persons in this category shall disclose all investments  
2 and business positions in business entities and income from any source which provides, or  
3 contracts with the City and County of San Francisco and its Airport Commission to provide  
4 services, supplies, materials, machinery or equipment to the Airport Commission.

5 (b) Disclosure Category 3. Persons in this category shall disclose all investments  
6 and business positions in business entities, interests in real property, and income from any  
7 source subject to the regulatory, permit or licensing authority of the Airport Commission.
