11 WHEREAS, Numerous studies indicate that the arts engage students and encourage
12 learning in a way that other academic curricula does not; and

13 WHEREAS, The Arts Education Program of the San Francisco Arts Commission is the
14 City's program that addresses the arts education needs of the San Francisco Unified School
15 District; and

16 WHEREAS, The Arts Education Program of the San Francisco Arts Commission works
17 in service to the San Francisco Unified School District and all students in San Francisco; and,

18 WHEREAS, The San Francisco Arts Commission has demonstrated substantial
19 experience and expertise in the field of arts education; and

20 WHEREAS, The National Endowment for the Arts has agreed to grant monies from its
21 Learning in the Arts for Children and Youth Program to the San Francisco Arts Commission to
22 support its excellent arts education programs; now, therefore be it

23 RESOLVED, That Board of Supervisors hereby authorizes the Arts Commission to
24 accept and expend a grant in the amount of \$50,000 from the National Endowment for the






