WHEREAS, The Ingleside Branch Library has been located in various leased storefront spaces since 1925; and,

WHEREAS, The San Francisco Public Library purchased and demolished the Sunset Garage on the corner of Ocean and Plymouth to build a new 6,100 square foot branch library; and

WHEREAS, Highlights of the new library design include a prominent children's section, an expanded reading area, a designated teen area, a state of the art program room with after-hours access for community meetings, more functional staff spaces, new computers, wireless access to the internet, and room for more books, CDs, videos, DVDs & other materials; and,

WHEREAS, The new branch is designed by the architecture team of Fougeron

Architecture and Group 4 Architecture Research + Planning, Inc. and will be constructed by

CLW Builders, Inc.; and,

WHEREAS, The Library applied for and was successfully granted \$3.7 million from the State of California Library Bond Act of 2000 to partially fund the project; and

WHEREAS, The planning for the new branch has been a team effort between the San Francisco Public Library staff and administrators, Department of Public Works Division of Project Management and Bureau of Construction Management, Library Commissioners, Friends of the San Francisco Public Library, and members of the Ingleside community who are raising funds and helped design the branch to suit their neighborhood's needs; now, therefore, be it

RESOLVED, That the Board of Supervisors commends the San Francisco Public Library, the Friends of the San Francisco Public Library, the Department of Public Works, members of the Ingleside community, and the entire team for their dedication and hard work; and, be it
