On behalf of GLIDE, we write in support of Supervisor Dean Preston's resolution urging the Human Services Agency, Office of Economic and Workforce Development, and Planning Department to develop and implement a plan for a grocery store in the Tenderloin. Healthy, culturally appropriate, and affordable food should be available to all San Franciscans, including Tenderloin residents.

GLIDE's Daily Free Meals Program supports low-income community members who struggle with food insecurity. We are honored to be a part of an ecosystem of programs in the Tenderloin and across San Francisco that works so tirelessly to nourish our community. Adding a full-service grocery store to the Tenderloin's range of options would make a significant difference in the lives of so many residents of the Tenderloin neighborhood.

GLIDE is a leading social service provider in the Tenderloin neighborhood, and we believe in food for all — no exceptions, no exclusions. Our Daily Free Meals program has no eligibility requirements, providing three nutritious meals a day, 364 days per year. Prior to the pandemic, one in four San Franciscans — nearly a quarter of a million people — were experiencing food insecurity. The economic consequences of COVID-19 have only made it harder for low-income families and communities of color to meet their basic needs — Black and Latinx households with children were twice as likely as white families to struggle to afford food during the pandemic. In response to this growing need, we have had to expand our reach. In 2022-23, GLIDE served more than 611,000 free meals and delivered 10,306 meals and 5,500 grocery bags citywide through our new mobile service model. Despite reaching more people, we know we are not close to meeting the true need of missing meals.

The need for an affordable full-service grocery store is even more urgent now when San Franciscans are facing rising rates of food insecurity. Over 100,000 residents across 73,000 San Francisco households have been impacted by the end of emergency allotments of CalFresh, which provided additional food assistance through the first three years of the COVID-19 pandemic and ended last year. Food prices have also increased due to inflation, making it even harder for low-income Tenderloin residents to access and afford food.

Increasing access to high quality, healthy, and affordable food in the Tenderloin and across San Francisco is at the core of GLIDE's mission to build empathy, transform lives, and spread radical inclusivity. As a champion for food equity, we support an intentional effort to bring a full-service grocery store to the Tenderloin to provide our community members with fresh and affordable food.
