3	Resolution receiving Overdose Prevention Policies for the Department of Public Health
4	the Department of Homelessness and Supportive Housing, the Department of
5	Emergency Management, and the Human Services Agency describing how the
6	department and its grantees that provide direct services to clients who use drugs will
7	promote strategies to reduce drug overdoses, submitted as required by Administrative
8	Code, Section 15.17.

10	WHEREAS, On June 25, 2021, the San Francisco Board of Supervisors passed an
11	ordinance amending the Administrative Code to require the Department of Public Health, the
12	Department of Homelessness and Supportive Housing, the Human Services Agency, and the
13	Department of Emergency Management to develop and submit to the Board of Supervisors
14	departmental overdose prevention policies; and
15	WHEREAS, Administrative Code, Section 15.17 requires each department to submit to
16	the Board of Supervisors a departmental policy describing how the department and its
17	grantees that provide direct services to clients who use drugs will promote strategies to
18	reduce drug overdoses ("Overdose Prevention Policy"); and
19	WHEREAS, All City Departments who interact with persons who use drugs have an
20	equal responsibility to respond to the rise in overdoses in a universal way that will have the
21	most impact; and
22	WHEREAS, The Department of Public Health, the Department of Homelessness &
23	Supportive Housing, the Department of Emergency Management, and the Human Services
24	Agency, are committed to a collective and collaborative approach to overdose prevention; and

1	WHEREAS, Each submitted departmental overdose prevention policy includes the
2	following components:
3	(a) A description of how departmental programs provide or refer clients to drug
4	treatment and harm reduction programs and services; and
5	(b) A description of where the department will make materials and resources
6	regarding overdose prevention and the continuum of services available to
7	clients; and
8	(c) An onsite overdose response policy that describes the steps the department
9	will take in the event that an individual overdoses on property managed by the
10	department or in the presence of department personnel; and
11	(d) A plan for department staff who work with people who use drugs to receive
12	training in overdose prevention strategies; and
13	(e) A description of the process by which the department will ensure that
14	grantees that manage property on behalf of the department and/or provide direct
15	services to people who use drugs implement overdose prevention policies; and
16	WHEREAS, The 2021, 2022, 2023, and 2024 Overdose Prevention policies for each
17	department are on file with the Clerk of the Board of Supervisors in File Nos. 211304, 221275,
18	231276, and 250018; and
19	WHEREAS, The Department of Public Health, Department of Homelessness and
20	Supportive Housing, the Department of Emergency Management, and the Human Services
21	agency have updated their departmental Overdose Prevention policies for 2025; and
22	WHEREAS, The aforementioned 2025 Overdose Prevention policies for each
23	department are on file with the Clerk of the Board of Supervisors in File No, which is
24	hereby declared to be a part of this Resolution as if set forth fully herein; now, therefore, be it

2	overdose prevention policies for the Department of Public Health, Department of
3	Homelessness and Supportive Housing, Human Services Agency, and Department of
4	Emergency Management.
