2 AUTHORIZING THE CHIEF OF POLICE FOR THE CITY AND COUNTY OF SAN
3 FRANCISCO TO RETROACTIVELY ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF
4 \$20,000 FROM THE CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL
5 FOR A PROJECT ENTITLED THE DECOY SHOULDER TAP PROGRAM.

7 WHEREAS, the Chief of Police of the City and County of San
8 Francisco desires to undertake a certain project designated the
9 "Decoy Shoulder Tap Program" funded from funds made available through
10 the California Department of Alcoholic Beverage Control (herein
11 referred to as "ABC") for reducing the availability of alcohol to
12 minors and reduce the number of drunk driving crashes by teenagers;
13 and,

14 WHEREAS, the Shoulder Tap is a common method by underage minors
15 to solicit strangers in front of ABC licensed premises where the
16 minor requests an adult to purchase and furnish them with an
17 alcoholic beverage; and,

18 WHEREAS, the grant terms prohibit including indirect costs in
19 the grant budget; now, therefore, be it

20 RESOLVED, That the Chief of Police of the City and County of San
21 Francisco is authorized on behalf of the City and County of San
22 Francisco to accept and expend funding for this project from ABC; and
23 be it

24 FURTHER RESOLVED, That the Board of Supervisors hereby waives
25 inclusion of indirect costs in the grant budget; and be it


FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.




