18 and nurturing early childhood development; representatives of local school districts; and  
19 representatives of local medical, pediatric, or obstetric associations or societies), for the  
20 unexpired portion of a four-year term ending December 24, 2002;

21 Lucy Crain, succeeding Nancy Torres, (Seat No. 9, must represent one or more of the  
22 following: children services, public health services; behavioral health services, social services  
23 and tobacco and other substance abuse prevention and treatment services; recipients of  
24 project services included in the county strategic plan; educators specializing in early  
25 childhood development; representatives of a local child care resource or referral agency, the

1 Child Care Planning and Advisory Council or another local child care coordinating group;  
2 representatives of a local organization for prevention or early intervention for families at risk;  
3 representatives of community-based organizations that have the goal of promoting and  
4 nurturing early childhood development; representatives of local school districts; and  
5 representatives of local medical, pediatric, or obstetric associations or societies), for the  
6 unexpired portion of a four-year term ending December 24, 2002.


