

1 [Parking and Traffic Regulations]

2 ADOPTING FINDINGS PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT,  
3 AND ENACTING AND RESCINDING PARKING AND TRAFFIC REGULATIONS ON  
4 PORTIONS OF MISSION STREET AND JESSIE STREET.

5 WHEREAS, In Resolution No. 812-00, a copy of which is on file with the Clerk  
6 of the Board of Supervisors in File No. 001265, this Board of Supervisors affirmed the  
7 Planning Commission's and Redevelopment Commission's certification of the Final  
8 Supplemental Environmental Impact Report for the Yerba Buena Redevelopment Project Area  
9 Expansion/Emporium Site Development (SCH. No. 98072072) (the "FSEIR") as adequate and  
10 complete pursuant to the California Environmental Quality Act ("CEQA"), the State CEQA  
11 Guidelines, and Chapter 31 of the San Francisco Administrative Code. In such Resolution, this  
12 Board also adopted findings in connection with the FSEIR, including an Addendum thereto, and  
13 its actions related to the Yerba Buena Redevelopment Project Area Expansion, including the  
14 actions contemplated herein, and adopted a mitigation monitoring and reporting program;

15 WHEREAS, On August 1, 2000, the Parking and Traffic Commission unanimously  
16 recommended the regulatory changes listed in this Resolution; now, therefore be it

17 RESOLVED, That this Board hereby incorporates by reference as if fully set forth herein  
18 Resolution No. 812-00, a copy of which is on file with the Clerk of the Board of  
19 Supervisors in File No. 001265, including such Resolution's findings and mitigation  
20 program, and relies on such Resolution as the CEQA basis for the actions proposed in this  
21 resolution; and, be it

22 FURTHER RESOLVED, That, in accordance with the provisions of the California Vehicle  
23 Code and the San Francisco Traffic Code, the following regulations governing the parking of  
24 vehicles and movement of traffic are hereby enacted or rescinded as designated below:

1 **TOW-AWAY, NO STOPPING, 3 PM - 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

2 Mission Street, north side, from 214 feet to 379 feet east of 5th Street (165-foot zone)

3 Mission Street, north side, from 274 feet to 341 feet west of 4th Street (67-foot zone)

4 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

5 Mission Street, north side, from 165 feet to 214 feet east of 5th Street (49-foot zone)

6 Mission Street, north side, from 335 feet to 490 feet east of 5th Street (155-foot)

7 Mission Street, north side, from 228 feet to 274 feet west of 4th Street (46-foot zone)

8 Jessie Street East, east side, between Mission and Jessie Streets

9 Jessie Street West, west side, between Mission and Jessie Streets

10 Jessie Street, north side, between 4th Street and Jessie Street East

11 Jessie Street, north side, between 5th Street and Jessie Street West

12 **NO LEFT TURNS - ESTABLISH**

13 Mission Street, both directions, between 4th and 5th Streets (prohibits mid-block left turns)

14 **ONE-WAY STREET - RESCIND**

15 Jessie Street, eastbound, between 5th Street and Jessie Street West

16 **ONE-WAY STREET - ESTABLISH**

17 Jessie Street, westbound, between 5th Street and Jessie Street West

18 Jessie Street East, northbound, between Mission and Jessie Streets

19 Jessie Street West, northbound, between Mission and Jessie Streets

20 **TAXI AND BUS LOADING ZONES - ESTABLISH**

21 Jessie Street East, west side, from Jessie Street to 110 feet southerly (110-foot zone)

22 Jessie Street West, east side, from Jessie Street to 112 feet southerly (112-foot zone)


