12 conditional use authorization is required from the Planning Department for the Type 41; and,

13 WHEREAS, The Police Department recommends that the liquor license application be approved; now,

15 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,
16 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that
17 the transfer of a Type 21 off-sale general and Type 41 on-sale beer and wine for bona-fide public eating place
18 licenses to Rita and Arsen Melkonian for :Arsen's Liquor and Deli, located at 1754 Polk Street, will serve the
19 convenience of the people of the City and County of San Francisco.




