3 **Ordinance authorizing settlement of the lawsuit filed by Isabel Rodriguez-Alba against**
4 **the City and County of San Francisco for \$55,000; the lawsuit was filed on**
5 **November 10, 2015, in San Francisco Superior Court, Case No. CGC-15-548917; entitled**
6 **Isabel Rodriguez-Alba v. City and County of San Francisco; the lawsuit involves an**
7 **injury when plaintiff tripped and fell in a pothole.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Isabel Rodriguez-Alba v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-15-548917 by the
13 payment of \$55,000. The lawsuit involves an injury when plaintiff tripped and fell in a pothole.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 November 10, 2015, and the following parties were named in the lawsuit: Plaintiff: Isabel
16 Rodriguez-Alba; Defendant: City and County of San Francisco.




