Resolution approving Lease Agreement No. 17-0112 between Alliance Ground International, LLC and the City and County of San Francisco, acting by and through its Airport Commission, for exclusive use of approximately 40,778 square feet of space in Airport Building 648, for an estimated total minimum rent of \$3,820,253 and a projected term of three years and seven months.

WHEREAS, By Airport Commission Resolution No. 17-0112, adopted on May 16, 2017, the Airport Commission approved a lease with Alliance Ground International, LLC for approximately 40,778 square feet of exclusive use space in Airport Building 648 for air cargo operations, commencing on the first day of the month following full City approval and expiring on May 31, 2021 (the "Lease"); and

WHEREAS, The rent for the first year of the Lease is \$24.92 per square foot, with subsequent adjustments based on Airport Rates and Charges, with a minimum rent estimated to be \$3,820,253 over the term of the Lease; and

WHEREAS, A copy of the form of the Lease, together with the Airport Commission Resolution approving the Lease, are on file with the Clerk of the Board of Supervisors in File No. 170668, which are hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That this Board of Supervisors hereby approves and authorizes the execution of Lease Agreement No. 17-0112 between Alliance Ground International, LLC and the City and County of San Francisco, acting by and through its Airport Commission, with an estimated minimum rent of be \$3,820,253 over the term of the Lease, which will commence on the first day of the month following full City approval and expire on May 31, 2021; and, be it

FURTHER RESOLVED, That within 30 days of the Lease being fully executed by all parties, the Airport Commission shall provide a copy of the final Lease to the Clerk of the Board for inclusion into the official file.
