3 **Resolution appointing Mark Heinzelman, Russell Keil, and Stephen Brett, terms ending**  
4 **June 30, 2004, to the Union Square Business Improvement District Advisory Board;**  
5 **waiving residency requirement.**

7       RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the Union  
9 Square Business Improvement District Advisory Board, pursuant to the provisions of  
10 Resolution No. 1066-98, for the term specified:

11       Mark Heinzelman, Seat 3, succeeding Jordan Meisner, must be property owner within  
12 the business improvement district, for unexpired portion of a five-year term ending June 30,  
13 2004;

14       Russell Keil (residency requirement waived), Seat 5, succeeding James Flood, must be  
15 property owner within the business improvement district, for unexpired portion of a five-year  
16 term ending June 30, 2004;

17       Stephen Brett (residency requirement waived), Seat 6, succeeding Ann Paolini, must  
18 be property owner within the business improvement district, for unexpired portion of a five-  
19 year term ending June 30, 2004; and, be it

20       FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 21       1. The membership of the Union Square Business Improvement District Advisory  
22       Board has a goal to be representative of the diversity of the City and County of San  
23       Francisco.

- 1           2. Applicants Stephen Brett and Russell Keil, new appointees, who are not residents  
2           of San Francisco, are persons with experience that uniquely qualifies him/her to  
3           serve on the Union Square Business Improvement District Advisory Board.
- 4           3. The Union Square Business Improvement District Advisory Board has attempted to  
5           fill the positions, for which Stephen Brett and Russell Keil were nominated, with an  
6           individual who is a City resident and who has the specific experience, skills, and  
7           qualifications, but has been unable to do so at this time. The Rules Committee has  
8           certified that Stephen Brett and Russell Keil are qualified to serve on the Union  
9           Square Business Improvement District Advisory Board.
- 10          4. After exercising due diligence, the Board of Supervisors concludes that there is no  
11          other possible representatives, who are residents of San Francisco and who has  
12          the specific experience, skills, or qualifications possessed by this applicant, and  
13          who are willing to serve on the Union Square Business Improvement District  
14          Advisory Board at this time; and, be it

15           FURTHER RESOLVED, That the Board of Supervisors waives the residency  
16          requirement for Stephen Brett and Russell Keil, as allowed in cases where no qualified City  
17          resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that  
18          requires person(s) appointed to boards, commissions, and advisory bodies established by  
19          legislative act of the Board of Supervisors to be resident(s) of the City and County of San  
20          Francisco.




