16 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. Environmental and Land Use Findings.

19 (a) The Planning Department has determined that the actions contemplated in this

20 ordinance comply with the California Environmental Quality Act (California Public Resources

21 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of

22 Supervisors in File No. 181031 and is incorporated herein by reference. The Board of

23 Supervisors affirms this determination.

1 (b) On November 29, 2018, the Planning Commission, in Resolution No. 20347,
2 adopted findings that the actions contemplated in this ordinance are consistent, on balance,
3 with the City's General Plan and eight priority policies of Planning Code Section 101.1. The
4 Board of Supervisors adopts these findings as its own. A copy of said Resolution is on file
5 with the Clerk of the Board of Supervisors in File No. 181031, and is incorporated herein by
6 reference.

7 (c) Pursuant to Planning Code Section 302, the Board of Supervisors finds that this
8 Planning Code amendment will serve the public necessity, convenience, and welfare for the
9 reasons set forth in Planning Commission Resolution No. 20347, and the Board of
10 Supervisors incorporates such reasons herein by reference.

11
12 Section 2. Article 3 of the Planning Code is hereby amended by revising Section 311,
13 to read as follows:

14 **SEC. 311. PERMIT REVIEW PROCEDURES**

15 * * * *

16 (b) **Applicability.** Except as indicated herein, all building permit applications in
17 Residential, NC, NCT, and Eastern Neighborhoods Districts for a change of use;
18 establishment of a Micro Wireless Telecommunications Services Facility; establishment of a
19 Formula Retail Use; demolition, and/or new construction, and/or alteration of residential
20 buildings; and including the removal of an authorized or unauthorized residential unit, in RH,
21 RM, and RTO Districts shall be subject to the notification and review procedures required by
22 this Section 311. In addition, all building permit applications that would establish Cannabis
23 Retail or Medical Cannabis Dispensary Uses, regardless of zoning district, shall be subject to
24 the review procedures required by this Section 311. Notwithstanding the foregoing or an
25

1 other requirement of this Section 311, a change of use to a Child Care Facility, as defined in
2 Section 102, shall not be subject to the review requirements of this Section 311.

3 (1) **Change of Use.** For the purposes of this Section 311, a change of use is
4 defined as follows:

5 (A) **Residential, NC, and NCT Districts.** For all Residential, NC, and
6 NCT Districts, a change of use is defined as a change to, or the addition of, any of the
7 following land uses as defined in Section 102 of this Code: Adult Business, Bar, Cannabis
8 Retail, General Entertainment, Group Housing, Limited Restaurant, Liquor Store, Massage
9 Establishment, Medical Cannabis Dispensary, Nighttime Entertainment, Outdoor Activity Area,
10 Post-Secondary Educational Institution, Private Community Facility, Public Community
11 Facility, Religious Institution, Residential Care Facility, Restaurant, School, Tobacco
12 Paraphernalia Establishment, Trade School, and Wireless Telecommunications Facility. A
13 change of use from a Restaurant to a Limited-Restaurant shall not be subject to the provisions
14 of this Section 311. Any accessory massage use in the Ocean Avenue Neighborhood
15 Commercial Transit District shall be subject to the provisions of this Section 311.

16 (i) Exception-NC Districts in Supervisorial Districts 4 and 11.
17 Notwithstanding subsection 311(b)(1)(A), in the geographic areas identified in subsection
18 311(b)(1)(A)(ii) for NC Districts in Supervisorial Districts 4 and 11, building permit applications for
19 a change of use to the following uses shall be excepted from the provisions of subsections
20 311(d) and 311(e): Bar, General Entertainment, Limited Restaurant, Liquor Store, Massage
21 Establishment, Nighttime Entertainment, Outdoor Activity Area, Private Community Facility,
22 Public Community Facility, Restaurant, and Tobacco Paraphernalia Establishment.

23 (ii) Subsection 311(b)(1)(A)(i) shall apply to Neighborhood
24 Commercial Districts in the following geographic areas:
25

1 Area 1: shall comprise all of that portion of the City and County commencing at the point of the
2 intersection of the shoreline of the Pacific Ocean and a straight-line extension of Lincoln Way, and
3 proceeding easterly along Lincoln Way to 17th Avenue, and proceeding southerly along 17th Avenue to
4 Judah Street, and proceeding westerly along Judah Street to 19th Avenue, and proceeding southerly
5 along 19th Avenue to Sloat Boulevard, and proceeding westerly along Sloat Boulevard, and following a
6 straight-line extension of Sloat Boulevard to the shoreline of the Pacific Ocean and proceeding
7 northerly along said line to the point of commencement.

8 Area 2: shall comprise all of that portion of the City and County commencing at the point of the
9 intersection of Junipero Serra Boulevard and Brotherhood Way, and proceeding northerly along the
10 eastern edge of Junipero Serra Boulevard to Garfield Street, and proceeding easterly along Garfield
11 Street to Grafton Avenue, and continuing easterly along Grafton Avenue to Mount Vernon Avenue, and
12 proceeding easterly along Mount Vernon Avenue to Howth Street, and proceeding northerly along
13 Howth Street to Geneva Avenue, and proceeding easterly along Geneva Avenue to Interstate 280, and
14 proceeding northerly along Interstate 280 to the straight-line extension of Tingley Street, and
15 proceeding southerly along said line to Tingley Street, and proceeding southerly along Tingley Street to
16 Alemaney Boulevard, and proceeding easterly along Alemaney Boulevard to Congdon Street, and
17 proceeding southerly along Congdon Street to Silver Avenue, and proceeding easterly along Silver
18 Avenue to Madison Street, and proceeding southerly along Madison Street to Burrows Street, and
19 proceeding westerly along Burrows Street to Prague Street, and proceeding southerly along Prague
20 Street to Persia Avenue, and proceeding westerly along Persia Avenue to Athens Street, and
21 proceeding southerly along Athens Street to Geneva Avenue, and proceeding easterly along Geneva
22 Avenue to the intersection of Geneva Avenue and Carter Street, and proceeding westerly along the
23 southeastern boundary of Census Tract 0263.02, Block 3005 to the San Francisco/San Mateo county
24 border, and proceeding westerly along the San Francisco/San Mateo county border to Saint Charles
25 Avenue, and proceeding northerly along Saint Charles Avenue to Interstate 280, and proceeding

1 northeasterly along Interstate 280 to a northerly straight-line extension to Orizaba Avenue, and
2 proceeding northerly along said line to Alemany Boulevard, and proceeding westerly along Alemany
3 Boulevard to Brotherhood Way, and proceeding westerly along Brotherhood Way to the point of
4 commencement.

5 ~~Sunset. Unless reenacted, subsections 311(b)(1)(A)(i)-(ii) shall expire by operation of law 24~~
6 ~~months after the effective date of the ordinance in Board File No. 180482. Upon its expiration, the City~~
7 ~~Attorney is authorized to take steps to remove subsections 311(b)(1)(A)(i)-(ii) from the Planning Code.~~



9 Section 3. Effective Date. This ordinance shall become effective 30 days after
10 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
11 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
12 of Supervisors overrides the Mayor's veto of the ordinance.
13

14 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
15 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
16 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
17 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
18 additions, and Board amendment deletions in accordance with the "Note" that appears under
19 the official title of the ordinance.
