9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

11 San Francisco, et al., United States District Court, Case No. 17-cv-06405 by the payment
12 of \$60,000. The lawsuit involves alleged civil rights violation.




