8 Section 1. The San Francisco Traffic Code is hereby amended by repealing Section
9 176.33 thereof, which reads as follows:

10 ((**SEC. 176.33.** A prima facie speed limit of 35 miles per hour is hereby established
11 on San Jose Avenue between Randall and 29th Streets.))

12 Section 2. The San Francisco Traffic Code is hereby amended by adding Section
13 175.33 thereto, to read as follows:

14 **SEC. 175.33.** A prima facie speed limit of 30 miles per hour is hereby established
15 on San Jose Avenue between Randall and 29th Streets.




