1           Section 2. **Authorization to Accept and Expend Contract Funds.**


2           DPH is hereby authorized to retroactively accept and expend grant funds from the  
3 Department of Health and Human Services, National Institutes of Health (NIH) in the amount  
4 of \$373,619, including \$40,319 in indirect costs. This grant will support the "Serosorting  
5 among Men at Risk for HIV" project. DPH will subcontract with three agencies to fulfill the  
6 goals and objectives of this project, including ISIS Inc., The University of Pittsburgh, and  
7 PHFE Management Solutions. The period of this agreement is January 1, 2007 through  
8 December 31, 2007. Subsequent years of funding are contingent upon approval.

9           DPH is further authorized to furnish whatever additional information or assurances the  
10 funding agency may request in connection with this agreement, and execute any and all  
11 agreements necessary to complete the transfer of funds.


