10 Million Solar Roofs Program will allow the City and County of San Francisco to have a Summit  
11 of policy makers throughout the nation to discuss strategies on implementing programs to  
12 encourage renewable energy on commercial, municipal and residential buildings in San  
13 Francisco and throughout the nation, and

14 WHEREAS, Acceptance of this grant will also allow the City and County of San  
15 Francisco and its Public Utilities Commission to create two videos on "Installing Solar Panels"  
16 and "Installing Passive Solar Heaters" in English, Spanish and Cantonese for viewing by the  
17 residents of San Francisco; and,

18 WHEREAS, Acceptance of this grant would also allow the City and County of San  
19 Francisco and its Public Utilities Commission to work with community groups in the southeast  
20 corner of the City have a fair on renewable energy and the environment in April 2003;


21 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,

25 U.S. Department of Energy's Million Solar Roofs program; and be it






