3 **Resolution urging the San Francisco Public Utilities Commission to complete its**
4 **implementation plan of Proposition B and H by April 15, 2002.**

6 WHEREAS, The voters of San Francisco overwhelmingly adopted Proposition B, the
7 measure authorizing the Public Utilities Commission to issue \$100 million in revenue bonds
8 for solar and renewable energy programs; and,

9 WHEREAS, The voters also passed Proposition H overwhelmingly, which allows the
10 Board of Supervisors to issue revenue bonds for solar and renewable energy programs; and,

10

11 WHEREAS, San Francisco remains firmly committed to becoming a leader in solar
12 energy, and California's ongoing energy concerns have only reaffirmed the importance of
13 finding better means of producing energy; and,

13

14 WHEREAS, the single biggest contributor to global warming is pollution from coal and
15 oil fired power plants; and,

15

16 WHEREAS, the majority of the world's Nobel prize winning scientists have signed a
17 letter to the United Nations stating that global warming is the single biggest threat to the
18 planet; and,

18

19 WHEREAS, solar energy offers a clean, reliable, silent way to make electricity that will
20 help make our energy supply more secure while reducing greenhouse gases; and,

20

21 WHEREAS, solar energy systems are remarkably durable as evidenced by the fact that
22 the first solar arrays installed forty years ago are still in operation; and,

23 WHEREAS, because of our technology-based economy, San Francisco is more
24 dependent on electricity than ever before; and,

1 WHEREAS, as an earthquake-prone city, San Francisco is especially vulnerable to grid
2 failures; and,

3 WHEREAS, solar energy systems generate electricity at the source where it is
4 consumed and will provide power even when the electrical grid fails; and,

5 WHEREAS, San Francisco should set the gold standard when it comes to
6 environmentally sound practices and energy production; and,

7 WHEREAS, The Moscone Convention Center is currently soliciting bids for the first
8 large-scale solar energy project in the City, offering a great opportunity for the city to
9 implement Propositions B and H; and,

10 WHEREAS, The PUC is developing a 10-year implementation plan for Propositions B
11 and H that prioritizes the largest and most practical projects to be completed first in order to
12 insure effective implementation of the bond programs; now, therefore, be it

13 RESOLVED, that the Board of Supervisors hereby urges the San Francisco Public
14 Utilities Commission to complete its solar implementation plan by April 15, 2002.




