

1 [Appointment - Back Streets Business Advisory Board]

3 **Resolution appointing Robert Legallet, term ending November 16, 2006, to the Back**  
4 **Streets Business Advisory Board; residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated person to serve as a member of the Back  
8 Streets Business Advisory Board, pursuant to the provisions of Ordinance No. 279-04 and  
9 Administrative Code Sections 5.260 through 5.265, for the term specified:

10 Robert Legallet (residency requirement waived), new appointment, seat 1, must be a  
11 current or former owner, operator, or officer of a light PDR Back Streets business located in  
12 San Francisco, for the unexpired portion of a two-year term ending November 16, 2006.

13 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Back Streets Business Advisory Board has a goal to be  
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicant Robert Legallet, a new appointee, who is not a resident of San Francisco,  
17 is a person with experience that uniquely qualifies him/her to serve on the Back  
18 Streets Business Advisory Board.
- 19 3. The Back Streets Business Advisory Board has attempted to fill the position, for  
20 which Robert Legellat was nominated, with an individual who is a City resident and  
21 who has the specific experience, skills, and qualifications, but has been unable to  
22 do so at this time. The Rules Committee has certified that Robert Legellat is  
23 qualified to serve on the Back Streets Business Advisory Board.
- 24 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
25 other possible representative, who is a resident of San Francisco and who has the

1 specific experience, skills, or qualifications possessed by this applicant, and who is  
2 willing to serve on the Back Streets Business Advisory Board at this time; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
4 requirement for Robert Legallet, as allowed in cases where no qualified City resident, willing  
5 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
6 appointed to boards, commissions, and advisory bodies established by legislative act of the  
7 Board of Supervisors to be resident(s) of the City and County of San Francisco.




