3 **Resolution celebrating 2022 as the Year of the Tiger, and recognizing February 1, 2022,**  
4 **as the start of Lunar New Year 4720 in the City and County of San Francisco.**

6 WHEREAS, 2022 marks Lunar year 4720, the Year of the Tiger, which begins on  
7 Tuesday, February 1, 2022; and

8 WHEREAS, Celebrations for the Lunar New Year begin with the New Moon on the first  
9 day of the new year and end on the full moon 15 days later; and

10 WHEREAS, The first Chinese New Year Parade took place in San Francisco's  
11 Chinatown in 1885 with a 15-day celebration and a block-long golden dragon preceded by the  
12 red pearl of potentiality; and

13 WHEREAS, In an effort to celebrate Chinatown and draw visitors to Chinese-owned  
14 businesses, the Chinese Chamber of Commerce transformed the Chinese New Year  
15 celebration into a Street Carnival at Portsmouth Square in 1953; and

16 WHEREAS, To further its efforts to promote Chinatown, the Chinese Chamber of  
17 Commerce launched the first Miss Chinatown, U.S.A. beauty pageant in 1958 as part of the  
18 New Year festivities; and

19 WHEREAS, The Chinese New Year parade draws larger crowds each year with  
20 increased marching units and floats, and is, to date, the largest parade celebrating Chinese  
21 New Year in the United States; and,

22 WHEREAS, The celebration of Chinese New Year in San Francisco has become a  
23 culturally significant civic pride event for our city; and

24 WHEREAS, The annual Chinese New Year parade and nearly month-long festivities  
25 that now include a Flower Market Fair, Choy Sun Doe, Basketball Jamboree, and a

1 Chinatown YMCA Run, in addition to the Community Street Fair, have provided an economic  
2 boost to our local economy beyond Chinatown; and

3 WHEREAS, The Lunar New Year may be known as Chinese New Year and the Spring  
4 Festival, but it is also celebrated as Solnal in Korean communities, with the Tet Festival by the  
5 Vietnamese, and as Losar in Tibet; and

6 WHEREAS, The Lunar New Year is a significant holiday for Asian families to gather  
7 together, honor their ancestors, welcome the New Year with hopes of prosperity and good  
8 health, and celebrate traditions and traditional foods; and

9 WHEREAS, During the COVID-19 pandemic, Lunar New Year themes of family, health  
10 and prosperity, renewal, and togetherness are especially important and families have found  
11 new ways to celebrate in order to protect the most vulnerable in our communities; and

12 WHEREAS, Due to COVID-19 health orders, all long standing of Lunar New Year  
13 celebrations and festivities were impacted and cancelled in 2021, the Year of the Ox;

14 WHEREAS, In 2022, while COVID-19 is still impacting long standing Lunar New Year  
15 celebrations, San Francisco is finally able to safely celebrate the Chinese New Year Parade  
16 and other outdoor festivities in accordance with the City's public health orders; now, therefore,  
17 be it

18 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
19 bids farewell to 2021, Year of the Ox, and commits to celebrate Asian families and Lunar New  
20 Year Festivities in accordance with the City's public health orders; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San  
22 Francisco wishes all families good luck, prosperity, and continued good health in the Year of  
23 the Tiger; and, be it
