3 **Ordinance authorizing settlement of the portion of the lawsuit filed by David Cheung,**
4 **individually and dba Kwok Shing Hong against the City and County of San Francisco**
5 **for \$350,000; the lawsuit was filed on January 31, 2005, in San Francisco Superior**
6 **Court, Case No. 436930; entitled Jane Martin, et al. v. City and County of San Francisco,**
7 **et al.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The City Attorney is hereby authorized to settle the portion of the action
10 entitled "Jane Martin, et al. v. City and County of San Francisco, et al.," San Francisco
11 Superior Court, Court No. 436930, as it relates only to co-plaintiff David Cheung, individually
12 and dba Kwok Shing Hong, by the payment of \$350,000, and excluding the claim by this
13 plaintiff for diminution of property value, attorney's fees, costs and interest, which will be
14 addressed in later proceedings.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff David
17 Cheung, individually and dba Kwok Shing Hong and Defendant City and County of San
18 Francisco.
