3 Ordinance authorizing settlement of the lawsuit filed by Bryan Vestal against the City
4 and County of San Francisco for \$420,000; the lawsuit was filed on February 3, 2011, in
5 San Francisco Superior Court, Case No. CGC-11-507921; entitled Bryan Vestal v. City
6 and County of San Francisco, et al.; another material term of said settlement is the
7 waiver of the San Francisco General Hospital medical lien in the amount of \$110,098.30.

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The City Attorney is hereby authorized to settle the action entitled "Bryan
11 Vestal v. City and County of San Francisco, et al.", San Francisco Superior Court, Court No.
12 CGC-11-507921 by the payment of \$420,000 and waiver of the San Francisco General
13 Hospital medical lien in the amount of \$110,098.30.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 February 3, 2011, and the following parties were named in the lawsuit: Plaintiff Bryan Vestal,
16 Defendants City and County of San Francisco and Tim Michael Reynolds.
