

[Charter Amendment - Housing and Development Commission]

Describing and setting forth a proposal to the voters, at an election to be held on November 8, 2016, to amend the Charter of the City and County of San Francisco, to create the Housing and Development Commission to oversee the Department of Economic and Workforce Development, and the Department of Housing and Community Development, ~~and the Department of Real Estate~~; to require the Commission to review and make recommendations regarding proposed development agreements and conveyance of certain surplus City property before the Board of Supervisors considers such proposals; to require the Commission to hold hearings and make recommendations regarding proposals to adopt or change inclusionary housing requirements for housing developments; and to require the Commission to adopt rules creating competitive selection processes for the Department of Housing and Community Development’s expenditure of affordable housing funds and for the development of affordable housing on City-owned property under the jurisdiction of the Department of Housing and Community Development.

Section 1. The Board of Supervisors hereby submits to the qualified voters of the City and County, at an election to be held on November 8, 2016, a proposal to amend the Charter of the City and County by adding Section 4.133 and revising Sections ~~4.129~~, 15.105, and 16.110, to read as follows:

SEC. 4.133. HOUSING AND DEVELOPMENT COMMISSION

(a) Membership and Terms of Office.

1 (1) The Housing and Development Commission shall consist of five members,
2 appointed as follows:

3 (A) Seats 1 and 2 shall be appointed by the Mayor. Seat 1 shall be held
4 by a person with significant experience in the field of affordable housing development or
5 community development. Seat 2 shall have no required qualifications in addition to those set
6 forth in Section 4.101.

7 (B) Seats 3 and 4 shall be appointed by the Board of Supervisors. Seat 3
8 shall be held by a person with significant experience in the field of affordable housing
9 development or community development. Seat 4 shall have no required qualifications in addition
10 to those set forth in Section 4.101.

11 (C) Seat 5 shall be appointed by the Controller, and shall be a person
12 with significant experience in the field of finance.

13 (2) Commissioners shall serve four-year terms, beginning at noon on March 1,
14 2017; provided, however, the term of the initial appointees in Seats 2 and 4 shall expire at noon
15 on March 1, 2019, and the term of the initial appointees in Seats 1, 3, and 5 shall expire at noon
16 on March 1, 2021.

17 (3) No person may serve more than two successive terms as a Commissioner. No
18 person having served two successive terms may serve as a Commissioner until at least four years
19 after the expiration of the second successive term. For purposes of this subsection (c), service
20 for a part of a term that is more than half the period of the term shall count as a full term, and
21 service that is half or less than half the period of a term shall not count as a full term; further,
22 this subsection makes no distinction between two-year terms and four-year terms.

23 (4) Commissioners may be removed from office only for official misconduct
24 under Article XV.

25 (b) Powers and Duties.

1 (1) With regard to the ~~three-two~~ departments described in subsection (c), and
2 subject to the transition provision in subsection (d)(3), the Commission shall exercise all the
3 powers and duties of boards and commissions set forth in Sections 4.102, 4.103, and 4.104,
4 except that the Commission shall have the exclusive power to appoint, evaluate, and remove the
5 department heads of the ~~three-two~~ departments.

6 (2) In addition to any other process or approvals required by law, including but
7 not limited to review by the Planning Commission, the Commission shall review and recommend
8 to the Board of Supervisors whether to approve a development agreement that the Department of
9 Economic and Workforce Development participated in negotiating under California Government
10 Code Section 65864 et seq. or any successor State legislation, before the Board of Supervisors
11 considers whether to approve the development agreement. The Commission may recommend
12 that the Board of Supervisors approve or reject the development agreement, and may also
13 recommend specific changes to the development agreement for consideration by the Board of
14 Supervisors. If the Board of Supervisors approves changes to a development agreement after the
15 Commission's hearing, the Board of Supervisors shall not be required to refer the development
16 agreement back to the Commission for further review or recommendations.

17 (3) In addition to any other process or approvals required by law, and except as
18 set forth in subsection (f) below, the Commission shall review and recommend to the Board of
19 Supervisors whether to approve any fee simple absolute conveyance of surplus real property
20 owned by the City, before the Board of Supervisors considers whether to approve the
21 conveyance. For the purpose of this Section 4.133, "surplus real property" shall mean any real
22 property that is not required to fulfill the mission of the City department, commission, or agency
23 with jurisdiction or control of such property, and that is not required to fulfill the mission of
24 another City department, commission or agency or other governmental entity, as determined by
25 the Board of Supervisors by resolution, and shall not include any real property that is sold or

1 exchanged for purposes other than housing development. The Commission may recommend that
2 the Board of Supervisors approve or reject a proposed fee simple absolute conveyance, and may
3 also recommend specific changes for consideration by the Board of Supervisors. If the Board of
4 Supervisors approves changes to a proposed fee simple absolute conveyance after the
5 Commission's hearing, the Board of Supervisors shall not be required to refer the matter back to
6 the Commission for further review or recommendations.

7 (4) The Commission shall adopt rules to create competitive selection processes
8 for (A) the development of affordable housing on City-owned real property under the jurisdiction
9 of the Department of Housing and Community Development, and (B) the Department of Housing
10 and Community Development's expenditure of the City's affordable housing funds. Such rules
11 may include exceptions and limitations as deemed appropriate by the Commission to maximize
12 and expedite the creation of affordable housing and leverage the City's affordable housing
13 funds, maintain existing affordable housing, increase funding to previously selected projects,
14 provide funding availability on a rolling basis, and provide emergency funding. The rules may
15 also recognize affordable housing projects with federal or state funding sources, and exempt
16 such projects from the competitive bid process. Any such rules adopted by the Commission shall
17 supersede any ordinance, rule, process or regulation enacted by the City or adopted by the
18 voters before March 1, 2017, relating to a competitive bid process for the City's development of
19 affordable housing. The Commission shall transmit to the Board of Supervisors any rules
20 adopted by the Commission under this subsection (b)(4) within 24 hours of their adoption. The
21 rules adopted by the Commission shall become effective 60 days after the date of adoption unless
22 two-thirds of all members of the Board of Supervisors vote by motion to veto the rules before the
23 expiration of this 60-day period.

24 (5) In addition to any other process or approvals required by law, including but not
25 limited to review by the Planning Commission, the Commission shall review any proposed

1 ordinance that would set or change the minimum or maximum inclusionary or affordable
2 housing obligations for housing development projects. The Board of Supervisors and its
3 committees shall not hold any hearings on such a proposed ordinance until the Commission has
4 held a hearing to review the proposal, unless the Commission fails to hold a hearing within 90
5 days after the Clerk of the Board of Supervisors forwards the proposed ordinance to the
6 Commission for its consideration. The Commission may recommend that the Board of
7 Supervisors approve or reject the proposed ordinance, and may also recommend specific
8 changes to the proposed ordinance for consideration by the Board of Supervisors. If the Board
9 of Supervisors approves changes to such a proposed ordinance after the Commission's hearing,
10 the Board of Supervisors shall not be required to refer the proposed ordinance back to the
11 Commission for further review or recommendations. Any ordinance adopted by the Board of
12 Supervisors following the process set forth in this subsection (b)(5) shall supersede any ordinance
13 enacted by the City or adopted by the voters before March 1, 2017, setting or changing the
14 minimum or maximum inclusionary or affordable housing obligations for housing development
15 projects.

16 (c) Departments. The Commission shall oversee the following ~~three~~two departments,
17 which shall come into existence as stated in subsection (d)(3):

18 (1) Department of Economic and Workforce Development. Except as otherwise
19 provided for in this Charter, the Department of Economic and Workforce Development shall
20 oversee City programs related to private workforce development and job training; business
21 attraction and retention, including international businesses; real estate development projects
22 involving the City and other public or private property owners; commercial corridors
23 revitalization; community business districts; infrastructure financing districts; and any other
24 related responsibilities prescribed by ordinance. The Department of Economic and Workforce
25

1 Development may assist other departments, including the Planning Department, in negotiating
2 development agreements with private property owners.

3 (2) Department of Housing and Community Development. Except as otherwise
4 provided for in this Charter, the Department of Housing and Community Development shall
5 provide financing for the development, rehabilitation, and purchase of affordable housing in the
6 City; administer programs to finance the development of affordable housing; administer
7 programs to finance housing rehabilitation for low-income and moderate-income homeowners;
8 administer the City's below-market-rate inclusionary housing program; administer grants
9 programs to support community development and economic infrastructure; and undertake any
10 other responsibilities prescribed in Section 16.110 or by ordinance.

11 ~~(3) Department of Real Estate. Except as otherwise provided for in this Charter,~~
12 ~~and subject to Board of Supervisors approval under Section 9.118 and any such other limits on~~
13 ~~the delegation as the Board of Supervisors may adopt by ordinance, the Department of Real~~
14 ~~Estate shall manage all real estate of the City including its public buildings; acquire real~~
15 ~~property required for City purposes; sell or transfer surplus real property owned by the City;~~
16 ~~lease property by and for City departments; appraise real property and enter into appraisal~~
17 ~~services contracts with qualified appraisers; and undertake any other related responsibilities~~
18 ~~prescribed by ordinance.~~

19 (d) Transition provisions.

20 (1) The Mayor, the Board of Supervisors, and the Controller shall make initial
21 appointments to the Commission by no later than noon, March 1, 2017, when the Commission
22 shall come into existence.

23 (2) The Commission shall have its inaugural meeting by no later than April 1,
24 2017.

1 (3) Beginning May 15, 2017, the Department of Economic and Workforce
2 Development ~~and; the Department of Housing and Community Development; and the~~
3 ~~Department of Real Estate~~ shall come into existence, and shall succeed to the powers and duties
4 of the previously existing Office of Economic and Workforce Development and Office of Housing
5 and Community Development under the Mayor, ~~and the existing Real Estate Division under the~~
6 ~~City Administrator~~, respectively, and those offices ~~and division~~ shall cease to exist.

7 (e) Existing Contracts. Nothing in this Section 4.133 shall be interpreted to impair the
8 obligations of any existing contract entered into by the City before May 15, 2017, or require the
9 City to abandon a competitive bid or contractor selection process that started before May 15,
10 2017.

11 (f) Non-applicability. The requirements of this Section 4.133 shall not apply to any other
12 governmental entity, such as the Successor Agency to the Redevelopment Agency of the City and
13 County of San Francisco, or to any department, commission or agency of the City that has
14 exclusive jurisdiction over its real property, and shall not be interpreted to interfere with a
15 department's ability to carry out its core functions under this Charter. Without limiting the
16 foregoing, nothing in this Section is intended to amend or limit the rights and powers granted to
17 City commissions under Sections 4.112, 4.113, 4.114, 4.115, B3.581, Article V, or Article VIII A
18 of this Charter.

20 **~~SEC. 4.129. DEPARTMENT OF ADMINISTRATIVE SERVICES.~~**

21 ~~The director of the Department of Administrative Services shall purchase all supplies;~~
22 ~~equipment, and contractual services required by the several departments and offices of the City~~
23 ~~and County, except as otherwise provided in the Administrative Code. Except in cases of~~
24 ~~emergency, the director shall not enter into any contract or issue any purchase order unless the~~
25 ~~Controller shall certify thereon that sufficient unencumbered balances are available in the proper~~

1 ~~fund to meet the payments under such purchase order or contract as these become due. The~~
2 ~~director shall have charge of the central warehouses, central storerooms, central garage and shop.~~

3 ~~The director shall by rules and regulations approved by the Controller, designate and~~
4 ~~authorize appropriate personnel within the Department of Administrative Services to exercise the~~
5 ~~director's signature powers for purchase orders and contract.~~

6 ~~The director shall have authority to exchange used materials, supplies, and equipment to~~
7 ~~the advantage of the City and County, advertise for bids, and to sell and otherwise dispose of~~
8 ~~personal property belonging to the City and County. The director shall have authority to require~~
9 ~~the transfer of surplus personal property in any department to stores or to other departments.~~

10 ~~The director shall manage all public buildings, facilities and real estate of the City and~~
11 ~~County, unless otherwise provided for in this Charter.~~

12 ~~—Additional duties and functions of the Department of Administrative Services shall be~~
13 ~~assigned the City Administrator, by ordinance or pursuant to Section 4.132.~~

15 **SEC. 15.105. SUSPENSION AND REMOVAL.**

16 (a) ELECTIVE AND CERTAIN APPOINTED OFFICERS. Any elective officer, and
17 any member of the Airport Commission, Asian Art Commission, Civil Service Commission,
18 Commission on the Status of Women, Golden Gate Concourse Authority Board of Directors,
19 Health Commission, Human Services Commission, Juvenile Probation Commission, Municipal
20 Transportation Agency Board of Directors, Port Commission, Public Utilities Commission,
21 Recreation and Park Commission, Fine Arts Museums Board of Trustees, ~~Taxi Commission~~, War
22 Memorial and Performing Art Center Board of Trustees, Board of Education or Community
23 College Board is subject to suspension and removal for official misconduct as provided in this
24 section. Such officer may be suspended by the Mayor and the Mayor shall appoint a qualified
25 person to discharge the duties of the office during the period of suspension. Upon such

1 suspension, the Mayor shall immediately notify the Ethics Commission and Board of
2 Supervisors thereof in writing and the cause thereof, and shall present written charges against
3 such suspended officer to the Ethics Commission and Board of Supervisors at or prior to their
4 next regular meetings following such suspension, and shall immediately furnish a copy of the
5 same to such officer, who shall have the right to appear with counsel before the Ethics
6 Commission in his or her defense. The Ethics Commission shall hold a hearing not less than five
7 days after the filing of written charges. After the hearing, the Ethics Commission shall transmit
8 the full record of the hearing to the Board of Supervisors with a recommendation as to whether
9 the charges should be sustained. If, after reviewing the complete record, the charges are
10 sustained by not less than a three-fourths vote of all members of the Board of Supervisors, the
11 suspended officer shall be removed from office; if not so sustained, or if not acted on by the
12 Board of Supervisors within 30 days after the receipt of the record from the Ethics Commission,
13 the suspended officer shall thereby be reinstated.

14 (b) BUILDING INSPECTION COMMISSION, PLANNING COMMISSION, BOARD
15 OF APPEALS, ELECTIONS COMMISSION, ETHICS COMMISSION, HOUSING AND
16 DEVELOPMENT COMMISSION, AND ENTERTAINMENT COMMISSION. Members of the
17 Building Inspection Commission, the Planning Commission, the Board of Appeals, the Elections
18 Commission, the Ethics Commission, the Housing and Development Commission, and the
19 Entertainment Commission may be suspended and removed pursuant to the provisions of
20 subsection (a) of this section except that the Mayor may initiate removal only of the Mayor's
21 appointees and the appointing authority shall act in place of the Mayor for all other appointees.

24 **SEC. 16.110. HOUSING TRUST FUND.**
25

1 (a) **Creation of Fund.** There is hereby established a Housing Trust Fund to support
2 creating, acquiring and rehabilitating affordable housing and promoting affordable home
3 ownership programs in the City, as provided in this Section.

4 (b) **Definitions.** For purposes of this Section:

5 ~~—— (1) "Affordable Housing Fee" shall mean a fee calculated by the Mayor's Office~~
6 ~~of Housing Department of Housing and Community Development as the difference between the~~
7 ~~affordable sales price of a housing unit of a certain bedroom size and the cost of developing a~~
8 ~~comparable housing unit. The Mayor's Office of Housing Department of Housing and~~
9 ~~Community Development shall index the fee annually based on the annual percent change in the~~
10 ~~Construction Cost Index for San Francisco as published by Engineering News Record or a~~
11 ~~similar index selected by the Mayor's Office of Housing Department of Housing and Community~~
12 ~~Development.~~

13 ~~—— (2) "Area Median Income" or "AMI" shall mean the unadjusted area median~~
14 ~~income levels as calculated by the Mayor's Office of Housing Department of Housing and~~
15 ~~Community Development using data from the Department of Housing and Urban Development~~
16 ~~on an annual basis for the San Francisco area, adjusted solely for Household size, but not high~~
17 ~~housing cost area.~~

18 ~~—— (3) "Basic On-Site Inclusionary Requirement" shall mean 12% of the units in the~~
19 ~~principal project affordable to a Household whose initial household income does not exceed 90%~~
20 ~~of Area Median Income for ownership units and 55% for rental units, or an on-site requirement~~
21 ~~with an equivalent Inclusionary Housing Cost Obligation.~~

22 (4) "First Responder" shall mean a City employee who responds first in cases of
23 natural disaster or emergencies, including, but not limited to, all active uniformed, sworn
24 members of the San Francisco Police and Fire Departments.

1 ~~(5)~~ "General Fund Discretionary Revenues" shall mean revenues that the City
2 receives and deposits in its treasury, that are unrestricted, and that the City may appropriate for
3 any lawful City purpose.

4 ~~———— (6) "Gross floor area" shall have the meaning in Planning Code Section 102.9, or~~
5 ~~any successor section, as amended from time to time.~~

6 ~~(7)~~ "Household" shall mean any person or persons who reside or intend to reside
7 in the same housing unit.

8 ~~———— (8) "Mayor's Office of Housing" shall mean the Mayor's Office of Housing~~
9 ~~and Community Development or any successor City agency.~~

10 ~~———— (98) "Other Affordable Housing Fees" shall mean any fee imposed on residential~~
11 ~~development by the City as a condition of a development approval related to affordable housing,~~
12 ~~which fee shall be adjusted annually by the City using an index selected by the City, or any~~
13 ~~exactions on residential development related to affordable housing imposed by the City,~~
14 ~~excluding fees imposed under Planning Code Section 415.~~

15 ~~———— (109) "Planning Code Section 415" shall mean San Francisco Planning Code~~
16 ~~Section 415 as of July 1, 2012, together with the defined terms in Section 401 as of that same~~
17 ~~date, and any successor legislation adopted consistent with this Section 16.110. Notwithstanding~~
18 ~~the foregoing, the calculation of the applicable affordable housing fee for "buildings of over 120~~
19 ~~feet in height" shall be as set forth in Planning Code Sections 315(a)(1)(B) & (C) and 315.6(b)(1)~~

21 ~~———— (1110) "Inclusionary Housing Cost Obligation" shall mean an obligation equal to~~
22 ~~the applicable percentage of below market rate housing units required under Planning Code~~
23 ~~Sections 415.5, 415.6 or 415.7 multiplied by the then current Affordable Housing Fee required~~
24 ~~per unit. For purposes of calculating the cost burden of any legislative change, the Mayor's~~
25 ~~Office of Housing Department of Housing and Community Development shall use the average~~

1 ~~citywide unit mix for projects subject to Planning Code Section 415 within the past five years as~~
2 ~~applied to a hypothetical project of 100 units. For purposes of calculating the cost burden~~

6 **-(c) Funding.**

7 (1) In the Fiscal Year 2013-2014 budget, the City shall appropriate to the
8 Housing Trust Fund \$20 million.

9 (2) For the next 11 fiscal years, in each of the annual budgets for Fiscal Year
10 2014-2015 through Fiscal Year 2024-2025, the City shall appropriate to the Housing Trust Fund
11 an amount increasing by \$2.8 million per year, until the annual appropriation required by this
12 Section reaches \$50.8 million in the Fiscal Year 2024-2025 budget.

13 (3) In the annual budgets for Fiscal Year 2025-2026 through Fiscal Year 2042-
14 43, the City shall appropriate to the Housing Trust Fund an amount equal to the prior year's
15 appropriation, adjusted by the percentage increase or decrease in General Fund Discretionary
16 Revenues budgeted for the year compared to the prior year's original budgeted amount of
17 General Fund Discretionary Revenues.

18 (4) Should the City adopt a fixed two-year budget under Charter Section 9.101,
19 the adjustment for the Housing Trust Fund appropriation for the two years of the two-year
20 budget shall be based on the amount of General Fund Discretionary Revenues estimated for the
21 two-year period included in the budget.

22 (5) During Fiscal Years 2025-2026 through 2042-2043, if the Controller submits
23 a revised estimate of General Fund Discretionary Revenues for a given Fiscal Year or two-year
24 budget period that is lower than the amount originally budgeted for that period, then the Board
25 may, by ordinance, reduce the appropriation to the Housing Trust Fund for that budget period in

1 an amount that does not exceed the amount proportionate to the percentage shortfall in the
2 discretionary revenue projection.

3 (6) The Controller's method of calculating the amount of and changes in General
4 Fund Discretionary Revenues shall be consistent from fiscal year to fiscal year and with the
5 Controller's method for calculating those figures under Charter Sections 8A.105, 16.108, and
6 16.109. The Controller shall treat General Fund appropriations to the Housing Trust Fund as
7 reductions in General Fund Discretionary Revenues when calculating other funding allocations
8 that are tied to General Fund Discretionary Revenues, including funding allocations under
9 Charter Sections 8A.105, 16.108, and 16.109. The Controller shall correct errors in the estimate
10 of discretionary revenues for a fiscal year through an adjustment to the next fiscal year's
11 estimate.

12 (7) In any year during the term of this Section, the City may, in its discretion,
13 reduce its annual contribution to the Housing Trust Fund for that year by an amount equal to or
14 less than 56.7% of the annual debt service required to service any SB2113 Affordable Housing
15 Bonds issued after January 1, 2013. "SB2113 Affordable Housing Bonds" are bonds issued by
16 the City to support the acquisition and creation of replacement affordable housing citywide using
17 property tax increment from former Redevelopment project areas under California Health and
18 Safety Code Section 33333.7

19 (8) The Controller shall set aside and maintain the amounts appropriated to the
20 Housing Trust Fund under this Section, together with any interest earned thereon, and any
21 amount unexpended or uncommitted at the end of the fiscal year shall be carried forward to the
22 next fiscal year and, subject to the budgetary and fiscal limitations of this Charter, shall be
23 appropriated for the purposes specified in this Section.

24 (d) **Uses of the Housing Trust Fund.** The City may disburse monies from the Housing
25 Trust Fund through loans, grants or other types of payments, on terms determined by the ~~Mayor's~~

1 *Office of Housing Department of Housing and Community Development* in its sole discretion.

2 Any repayment of a loan or grant from the Fund that the City receives, or any interest from a
3 loan from the Fund that the City receives, will be returned to the Housing Trust Fund. The City,
4 acting through the *Mayor's Office of Housing Department of Housing and Community*
5 *Development*, shall disburse the monies from the Housing Trust Fund for the following eligible
6 expenditures:

7 (1) The creation, acquisition, and rehabilitation of rental and ownership housing
8 affordable to Households earning up to 120% of the Area Median Income, including, without
9 limitation, the acquisition of land for such purpose.

10 (2) No later than July 1, 2018, the City shall appropriate \$15 million from the
11 Housing Trust Fund to a program that provides loans to Households earning up to 120% of the
12 Area Median Income and to Households including a First Responder (subject to Area Median
13 Income limits designated by the *Mayor's Office of Housing Department of Housing and*
14 *Community Development*) for use as a down payment on the purchase of a housing unit ("the
15 Down Payment Assistance Loan Program"). As soon as is practical, the *Mayor's Office of*
16 *Housing Department of Housing and Community Development* shall develop and implement a
17 manual for the Down Payment Assistance Loan Program.

18 (3) No later than July 1, 2018, the City shall appropriate up to \$15 million from
19 the Housing Trust Fund to a program that provides funds to Households earning up to 120% of
20 Area Median Income for use as assistance to reduce the risk to current occupants of a loss of
21 housing and/or to help current occupants make their homes safer, more accessible, more energy
22 efficient, and more sustainable (the "Housing Stabilization Program"). As soon as is practical,
23 the *Mayor's Office of Housing Department of Housing and Community Development* shall
24 implement and develop a manual for the Housing Stabilization Program.

1 (4) The City may use monies in the Housing Trust Fund to operate and
2 administer the Infrastructure Grant Program as described in subsection (e). The City may not
3 allocate to the Infrastructure Grant Program in any fiscal year an amount exceeding the greater of
4 \$2 million or 10% of the amount appropriated to the Housing Trust Fund for that fiscal year
5 under subsection (c).

6 (5) In any fiscal year, the City may allocate a sufficient amount from the
7 Housing Trust Fund to pay for all legally permissible administrative costs of the Fund, including,
8 without limitation, legal costs, associated with any use of the Housing Trust Fund.

9 (e) **Complete Neighborhoods Infrastructure Grant Program.** After conferring with
10 the Director of Planning, the Director of the ~~Mayor's Office of Housing~~ Department of Housing
11 and Community Development shall design and administer a Complete Neighborhoods
12 Infrastructure Grant Program ("Infrastructure Grant Program"). The purpose of the Infrastructure

15 Infrastructure Grant Program only for public facilities identified in the Community Facilities

17 such monies by residential development project sponsors, community-based organizations, and
18 City departments for public realm improvements associated with proposed residential
19 development projects.

20 (f) **Bonding Authority.** Notwithstanding the limitations set forth in Sections
21 9.107, 9.108, and 9.109 of this Charter, upon recommendation of the Mayor, the Board of
22 Supervisors may authorize the issuance, without limitation, of revenue bonds, lease financing,
23 notes, or other evidences of indebtedness or other obligations ("Debt Obligations"), the proceeds
24 of which are to be used for creating, acquiring, and rehabilitating rental and ownership housing
25 affordable to Households earning up to 120% of the Area Median Income, including, without

1 limitation, the acquisition of land for such purpose. Such Debt Obligations shall be secured by
2 and/or repaid from any available funds pledged or appropriated by Board of Supervisors
3 ordinance for such purpose, which amount may include funds in the Housing Trust Fund
4 allocated under subsection (c). Debt Obligations authorized hereby shall be issued in accordance
5 with the *Mayor's Office of Housing Department of Housing and Community Development*
6 policies, and upon the terms and conditions as the Board of Supervisors shall approve. Funds
7 appropriated to pay debt service on the Debt Obligations in such fiscal year under the terms of
8 this Section shall be set aside in an account for such use until such payment is made.

5 Department, and the *Office Department* of Economic and Workforce Development, *or their*

16 by the Controller's Office regarding the financial feasibility of development subject to the

2 permit, that would require an increase in the project sponsor's Inclusionary Housing Cost
3 Obligation beyond that required as of January 1, 2013, including and incorporating the
4 reductions effected by subsection (g).

5 ~~———— (3) **Other Fees Related to Affordable Housing Fee.** As of January 1, 2013, the~~
6 ~~City may not adopt any new land use legislation or administrative regulation, including a~~
