Resolution authorizing and approving lease of City-owned property located on the first floor of the Hall of Justice, 850 Bryant Street, to the Northern California Service League.

WHEREAS, The Northern California Service League is a non-profit corporation which has provided a Children's Waiting Room in Room 106 and a Pre-release Program which provides social services to inmates and their families in Room 116 of the Hall of Justice since 1991; now, therefore, be it

RESOLVED, That in accordance with the recommendation of the Director of Administrative Services and the Director of Property, the Director of Property is hereby authorized to take all actions, on behalf of the City and County of San Francisco, as Landlord, to execute a one year lease with nine (9) one year options to extend with the Northern California Service League for rental space located on the first floor, commonly known as Rooms 106 and 116 of the Hall of Justice, 850 Bryant Street for a Children's Waiting Room and a Pre-release Program; and, be it

FURTHER RESOLVED, The proposed use provides a public benefit and as such, the rental of said property is established at One (\$1) Dollar per year; and, be it

FURTHER RESOLVED, The lease shall include a provision in which the City indemnifies, defends, and holds harmless the Lessees from and against any and all claims or liability for any injury or damages any person or property occurring as a result of City's acts or omissions or any default by City in the performance of its obligations under the (Real Estate)

leases. Said leases shall be in a form approved by the City Attorney; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Property to enter into any amendments or modifications to the Lease (including without limitation, the exhibits) that the Director of Property determines, in consultation with the City Attorney, are in the best interest of the City, do not increase the rent or otherwise materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the Lease or this resolution, and are in compliance with all applicable laws, including City's Charter.
