#### **Business and/or Professional Experience:**

I possess over two decades of housing and community development experience across the public, private and nonprofit sectors. I worked as a municipal urban planning for a decade, including 8 years with San Francisco's Planning Department, later I worked in the private sector directing development projects and community building efforts nationally. In recent years, I have worked in the nonprofit homelessness housing and economic development space including in San Francisco. I developed the City's first tiny homes project at 33 Gough as well as lead a place-based economic development project in San Francisco's downtown with the World Economic Forum. I am currently the Chief Strategy Officer at EBALDC, an anchor community development nonprofit, serving and providing affordable housing and permanent supportive housing to thousands of low-income and formerly homeless residents in the Bay Area (Alameda, Contra Costa and Santa Clara counties). My role encompasses strategic management for the organization as well as direct oversight for the Resident Community Services Department and the Community Planning and Placemaking Department.

I have always held a passion for civic engagement and leadership. I have had the honor of serving as a former appointed board member on the Treasure Island Development Authority (TIDA) and on the San Francisco Municipal Transportation Agency (SFMTA) Boards. During my tenure on TIDA we stewarded 8,000 units of housing including 2,000 affordable units, I also chaired the Infrastructure and Transportation committee. While serving on SFMTA, we oversaw public transit, streets as well as many capital projects including leveraging SFMTA properties for housing opportunities.

I currently serve on West Bay Pilipino Multi-Service Center's Board in San Francisco as well as serve as Secretary on Partners for Public Good's Board, a national nonprofit dedicated to providing procurement reform advisory services to government entities. In the past, I have also served our San Francisco community through my board membership with SF Hep B Free (healthcare initiative), Chinese Hospital Steering Committee, Junior League of San Francisco, and March of Dimes San Francisco.

I have lived in San Francisco for twenty-two of the last twenty-six years, and this city has shaped both my professional path and personal values. I immigrated to the United States as a child and was undocumented until receiving permanent residency through the 1986 IRCA amnesty law. During the first few years in our adopted country, we lived in private housing that was substandard and moved often. These experiences have given me a deep appreciation for how fair and effective public systems can change lives and open opportunity.				
As a Latina, an immigrant, a woman, first generation college graduate, and a mother raising three children in San Francisco, I represent several of the communities that define this city's identity. I understand the challenges faced by working families, immigrants, and seniors who seek stability and dignity in one of the most expensive cities in the nation.				

Business and/or Professional Experience:
I currently serve as Chief Executive Officer of Christian Church Homes (CCH), an East Bay-based nonprofit affordable housing organization that has been serving residents for nearly sixty-five years. CCH develops and manages affordable housing communities across six states. In this role, I oversee all aspects of the organizations operations, including strategy, finance, development, asset management, resident services, and compliance, and lead a team of over 220 employees.
Before becoming CEO, I served as Chief Operating Officer at CCH, where I guided the organization through a period of stabilization, modernization, and renewed focus on cross-departmental collaboration. My work includes deep engagement with HUD programs such as Section 8, PRAC, and RAD conversions, as well as extensive partnerships with state and local housing agencies.

Earlier in my career, I worked at two San Francisco rooted affordable housing organizations—Tenderloin Neighborhood Development Corporation (TNDC) and Chinatown Community Development Center (CCDC). Both organizations have partnered closely with the San Francisco Housing Authority and have benefited from its subsidies and programs. I also witnessed the challenges that can arise from administrative delays, limited communication, and the need for deeper collaboration. These experiences reinforce my belief that SFHA is a critical partner in the citys housing ecosystem and that strong, responsive governance can significantly improve outcomes for residents and nonprofit partners alike.

#### **Civic Activities:**

Throughout my career, I have been deeply engaged in civic and community efforts to expand access to affordable housing and improve coordination among public agencies, nonprofit partners, and residents. I have participated in national, state and local advocacy and collaborative organizations. I have collaborated with elected officials, city departments, and coalitions to advocate for equitable housing policies and greater accountability in the systems that serve low-income communities.

My work with local organizations such as TNDC, CCDC, as well as with Christian Church Homes has given me direct experience navigating partnerships with various housing authorities, including SFHA. I have seen both the successes that come from shared purpose and the frustrations that result from procedural barriers and communication gaps. Those experiences have strengthened my conviction that open dialogue, accountability, and consistency are essential to SFHAs success. As CEO at CCH, I lead a BiPOC leadership team and believe diversity and lived experiences add to the richness of our work.

Beyond my professional role, I mentor emerging leaders in the housing field, with a particular focus on women and professionals of color. I believe civic leadership requires humility, transparency, and a commitment to collaboration. If appointed, I would bring those values to the Commission and work to strengthen trust and communication between SFHA, its nonprofit partners, and the residents it serves.
