11 WHEREAS, The Police Department recommends that the liquor license application be approved with  
12 conditions; now, therefore, be it

13 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,  
14 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that  
15 the issuance of a Type 42 on-sale beer and wine-public premises alcoholic beverage control license, to Giday  
16 Beshue and Nebiat Tesfazgi for Club Waziema, located at 543 Divisadero will serve the convenience of the people  
17 of the City and County of San Francisco.

18 Conditions: (1) Sales, service or consumption of alcoholic beverages shall be permitted only between the  
19 hours of 11:00 a.m. and 12 midnight each day of the week. ; (2) Entertainment provided shall not be audible  
20 beyond the area under control of the licensee.


