10 000610, and


11 WHEREAS, The Grant of Easement was recorded in the San Mateo County Recorders Office
12 and subsequently, said property owner requested that the City and County of San Francisco rescind
13 the noise easement, and

15 WHEREAS, In accordance with Airport Commission Resolution No. 00-0074, a copy of
16 which is on file with the Clerk of the Board of Supervisors in file no 000610, the San
17 Francisco Airport Commission recommends the rescission of said grant of easement by the delivery
18 of quitclaim deed to said property owner, now, therefore, be it

19 RESOLVED, That this Board of Supervisors approves the rescission of said grant of
20 easement and hereby authorizes the Director of Property to prepare, execute, and deliver a quitclaim
21 deed to said respective property owner.




