

1 [Supporting the International Brotherhood of Teamsters at Amazon DCK6]

3 **Resolution supporting the International Brotherhood of Teamsters in their efforts to**

4 **bargain with Amazon Web Services on behalf of workers at the DCK6 Warehouse.**

6 WHEREAS, Over 100 workers at Amazon's DCK6 warehouse in San Francisco  
7 unionized with the Teamsters on October 2, 2024, demanding union recognition with union  
8 cards signed by the supermajority of workers at their warehouse; and

9 WHEREAS, Since October 2, 2024, Amazon has not recognized DCK6 workers,  
10 refused to bargain with the union, and allegedly responded with illegal retaliation and union  
11 busting; and

12 WHEREAS, In April 2025, the National Labor Relations Board Region 20 issued an  
13 initial complaint against Amazon for illegal union-busting activity at the DCK6 facility; and

14 WHEREAS, This complaint seeks to force Amazon to recognize the unions and begin  
15 good faith bargaining with Teamsters; and

16 WHEREAS, In June the NLRB issued another complaint against Amazon at the DCK6  
17 facility for more illegal union busting activity, asking Amazon to rehire fired workers and  
18 ensure union supporters receive raises, bonuses, and promotion, like their colleagues; and

19 WHEREAS, The 5 cases filed by the Teamster Amazon National Negotiating  
20 Committee International Brotherhood of Teamsters, detail a pattern of employer interference  
21 aimed at discouraging workers from organizing at DCK6; and

22 WHEREAS, Initial National Labor Relations Board (NLRB) complaint charges that  
23 Amazon retaliated against pro-union employees, rewarded anti-union sentiment with  
24 promotions, spread misinformation about unions, and restricted union-related conversations  
25 or gear; and

1        WHEREAS, Amazon management is also accused of intimidating workers, holding  
2 one-on-one interrogations, and an influx of union-busting personnel, while warning workers of  
3 negative consequences such as long contract delays, loss of benefits, or misuse of personal  
4 data; and

5        WHEREAS, The holidays are peak season for Amazon workers and during this time,  
6 logistics workers are often put under extreme pressure to meet quotas and work extended  
7 hours, with reports of increased workplace injuries, ignored safety procedures, and skipped  
8 meal, rest, and bathroom breaks; and

9        WHEREAS, Amazon hires many seasonal workers around the holidays, who are  
10 typically laid off once the holiday season ends; and

11       WHEREAS, DCK6 also operates as a last-mile delivery station, where packages arrive  
12 already packed, and sorted and led for delivery; and

13       WHEREAS, Last-mile facilities like DCK6, located on Toland Street in Bayview, tend to  
14 be concentrated in more marginalized communities, meaning that these warehouses create  
15 safety and health issues that disproportionately impact already vulnerable populations; and

16       WHEREAS, Union workers make significantly higher wages than their non-union  
17 counterparts in the United States, particularly in the private sector; and

18       WHEREAS, Many Amazon workers make significantly lower wages, experience less  
19 job stability, and have inferior working conditions compared to competing large, unionized  
20 logistics employers, such as workers at United Parcel Service, DHL, and the United States  
21 Postal Service; and

22       WHEREAS, All of these workers serve our community by processing and delivering  
23 critical goods and should be compensated and treated fairly; now, therefore, be it

24       RESOLVED, That Board of Supervisors supports Amazon DCK6 workers' unionization  
25 effort and their fight to win a fair contract; and, be it

1       FURTHER RESOLVED, That the Board of Supervisors recognizes the importance of  
2 Amazon workers and all logistics industry workers that make San Francisco run, especially  
3 during the holiday season; and, be it

4       FURTHER RESOLVED, That the Board of Supervisors calls upon Amazon to bargain  
5 with DCK6 Amazon Teamsters immediately to deliver fair contracts and wages, and improve  
6 the working conditions for workers at Amazon's DCK6 warehouse.
