3 **Ordinance amending the San Francisco Police Code by amending Sections 2901, 2902,**
4 **2904, 2907, 2908, 2909, 2910, 2916, and 2917, repealing Sections 2903, 2906, 2911, 2912,**
5 **2913, 2914, 2915, and 2918, and adding new Sections 2912, 2918, 2920, 2922, 2924, and**
6 **2926, to revise the City's noise control regulations, add administrative penalties, and**
7 **create a noise task force.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The San Francisco Police Code is hereby amended by amending Sections
14 2901, 2902, 2904, 2907, 2908, 2909, 2910, 2916, and 2917, repealing Sections 2903, 2906,
15 2911, 2912, 2913, 2914, 2915, and 2918, and adding new Sections 2912, 2918, 2920, 2922,
16 2924, and 2926, to read as follows:

17 **SEC. 2901. DEFINITIONS.**

18 *As used in this Article, unless the context otherwise clearly indicates, the words and phrases set*
19 *forth in Sections 2901.1 through 2901.14 inclusive, hereof, shall have the meaning respectively*
20 *ascribed to them in said sections.*

21 (a) "Ambient" means the lowest sound level repeating itself during a minimum fifteen-
22 minute period as measured with a type 1, precision sound level meter, using slow response and "A"
23 weighting. The minimum sound level shall be determined with the noise source at issue silent, and in
24 the same location as the measurement of the noise level of the source or sources at issue. However, for
25 purposes of this chapter, in no case shall the ambient be considered or determined to be less than: (1)

1 Thirty dBA for interior residential noise, and (2) Forty dBA in all other locations. If a significant
2 portion of the ambient is produced by one or more individual identifiable sources of noise that
3 contribute cumulatively to the sound level and may be operating continuously during the minimum
4 fifteen-minute measurement period, determination of the ambient shall be accomplished with these
5 separate identifiable noise sources silent or otherwise removed or subtracted from the measured
6 ambient sound level.

7 (b) "Director" means the Director or department head of any City department having
8 administrative or enforcement responsibilities under this Article or any other provision of the
9 Municipal Code regarding noise control, as well as his or her designee.

10 (c) "Dwelling Unit" means (1) a dwelling space consisting of essentially complete
11 independent living facilities for one or more persons, including, for example, permanent provisions for
12 living and sleeping; (2) a room in group housing, even if such room lacks private cooking facilities and
13 private plumbing facilities, such as rooms in senior citizen housing, single room occupancy or
14 residential hotels, dorms, hostels, or shelters; or, (3) a housekeeping room as defined in the Housing
15 Code.

16 (d) "Emergency work" means work made necessary to restore property to a safe condition
17 following a public calamity or work required to protect persons or property from an imminent exposure
18 to danger or work by private or public utilities when restoring utility service. This term shall not
19 include testing of emergency equipment.

20 (e) "Fixed source" means a machine or device capable of creating a noise level at the
21 property upon which it is regularly located, including but not limited to: industrial and commercial
22 process machinery and equipment, pumps, fans, air-conditioning apparatus or refrigeration machines.

23 (f) "Low frequency ambient" means the lowest sound level repeating itself during a fifteen-
24 minute period as measured with a sound level meter, using slow response and "C" weighting. The

1 minimum sound level shall be determined with the music or entertainment noise source at issue silent,
2 and in the same location as the measurement of the noise level of the source or sources at issue.
3 However, for purposes of this chapter, in no case shall the local ambient be considered or determined
4 to be less than: (1) Forty dBC for interior residential noise, and (2) Fifty dBC in all other locations. If
5 a significant portion of the ambient is produced by one or more individual identifiable sources that
6 would otherwise be operating continuously during the minimum fifteen-minute measurement period,
7 determination of the low-frequency ambient shall be accomplished with these separate identifiable
8 noise sources silent or otherwise removed or subtracted from the measured ambient sound.

9 (g) "Noise level" means the maximum continuous sound level or repetitive peak sound level,
10 produced by a source or group of sources as measured with a sound level meter. In order to measure a
11 noise level, the controls of the sound level meter should be arranged to the setting appropriate to the
12 type of noise being measured. For example, the settings should be slow response for continuous noise
13 sources and fast response for noises with rapid onset and decline.

14 (h) "Person" means a person, firm, association, copartnership, joint venture, corporation,
15 or any entity, public or private in nature.

16 (i) "Place of Entertainment" has the same meaning as the term is defined in San Francisco
17 Police Code Section 1060.

18 (j) "Powered construction equipment" means any tools, machinery, or equipment used in
19 connection with construction operations which can be driven by energy in any form other than
20 manpower, including all types of motor vehicles when used in the construction process of any
21 construction site, regardless of whether such construction site be located on-highway or off-highway,
22 and further including all helicopters or other aircraft when used in the construction process except as
23 may be preempted for regulation by State or Federal law.

1 (k) "Property plane" means a vertical plane including the property line that determines the
2 property boundaries in space.

3 (l) "Public Property" means property leased or owned by a governmental entity, to which
4 the public or a substantial group of persons has access, including but not limited to any street,
5 highway, parking lot, plaza, transportation facility, school, place of amusement, park, or playground
6 located within the City and County of San Francisco.

7 (m) "Residential Property" means any property that has at least one dwelling unit and has
8 been approved for human habitation by the City and County of San Francisco.

9 (n) "Sound level," expressed in decibels (dB), means a logarithmic indication of the ratio
10 between the acoustic energy present at a given location and the lowest amount of acoustic energy
11 audible to sensitive human ears and weighted by frequency to account for characteristics of human
12 hearing, as given in the American National Standards Institute Standard S1.1, "Acoustic Terminology,"
13 paragraph 2.9, or successor reference. All references to dB in this chapter refer to the A-level or C-
14 level weighting scale, abbreviated dBA or dBC, measured as set forth in this section.

16 **~~SEC. 2901.1. SOUND LEVEL (NOISE LEVEL).~~**

17 ~~Sound level (noise level) in decibels is the level measured on the A weighted scale as defined in~~
18 ~~the American National Standard S 1.4 1971.~~

19
20 **~~SEC. 2901.2. AMBIENT NOISE.~~**

21 ~~Ambient noise is the all encompassing noise associated with a given environment, being a~~
22 ~~composite of sounds from many sources, near and far. For the purpose of this Code, ambient noise~~
23 ~~level is the average over 15 minutes excluding random or intermittent noises and the alleged offensive~~
24

1 ~~noise at the location and time of day at which a comparison with an alleged offensive noise is to be~~
2 ~~made.~~

3 ~~Averaging may be done by instrumental analysis in accordance with American National~~
4 ~~Standard S.13-1971, or may be done manually as follows:~~

5 ~~(1) Observe a sound level meter for five seconds and record the best estimate of central~~
6 ~~tendency of the indicator needle, and the highest and lowest indications.~~

7 ~~(2) Repeat the observations as many times as necessary to provide that observations be made at~~
8 ~~the beginning and at the end of the 15 minute averaging period and that there shall be at least as many~~
9 ~~additional observations as there are decibels between the lowest low indication and the highest high~~
10 ~~indication.~~

11 ~~(3) Calculate the arithmetical average of the observed central tendency indications.~~

13 ~~**SEC. 2901.3. DECIBEL.**~~

14 ~~The decibel is a unit of measure of sound (noise) level relative to a standard reference sound on~~
15 ~~a logarithmic scale. The decibel level of a given sound is determined as 20 times the logarithm to the~~
16 ~~base 10 of the ratio of the pressure in micronewtons per square meter of the sound being measured to~~
17 ~~the standard reference sound pressure of 20 micronewtons per square meter (0.0002 microbar).~~

19 ~~**SEC. 2901.4. NONSTATIONARY SOURCES.**~~

20 ~~A machine or device capable of being moved from place to place for occasional or temporary~~
21 ~~use at a given location including, but not limited to, powered lawn mowers, chain saws, bulldozers and~~
22 ~~pile drivers.~~

24 ~~**SEC. 2901.5. FIXED SOURCE.**~~

25

1 ~~A machine or device capable of creating a noise level at the property upon which it is regularly~~
2 ~~located, including but not limited to: industrial and commercial process machinery and equipment,~~
3 ~~pumps, fans, air conditioning apparatus or refrigeration machines.~~

5 **~~SEC. 2901.6. EMERGENCY WORK.~~**

6 ~~Emergency work shall mean work made necessary to restore property to a safe condition~~
7 ~~following a public calamity or work required to protect persons or property from an imminent exposure~~
8 ~~to danger or work by private or public utilities when restoring utility service.~~

10 **~~SEC. 2901.7. PERSON.~~**

11 ~~Person shall mean a person, firm, association, copartnership, joint venture, corporation, or any~~
12 ~~entity, public or private in nature.~~

13
14 **~~SEC. 2901.8. MOTOR VEHICLES.~~**

15 ~~Motor vehicles shall include any and all self propelled vehicles as defined in California Vehicle~~
16 ~~Code, including all on highway type motor vehicles subject to registration under said Code, all off-~~
17 ~~highway type motor vehicles subject to identification under said Code, and all motor vehicles exempted~~
18 ~~under said Code; excepting on highway type motor vehicles when transporting any person or property~~
19 ~~on a public street or highway as defined in said Code, and all types of motor vehicles when used in any~~
20 ~~other manner, the regulation of which has been preempted by California State Law.~~

22 **~~SEC. 2901.9. COMMERCIAL PURPOSE.~~**

23 ~~Commercial purpose shall mean and include the use, operation, or maintenance of any sound~~
24 ~~amplifying equipment for the purpose of advertising any business, or any goods, or any services, or for~~

1 ~~the purpose of attracting the attention of the public to, or advertising for, or soliciting patronage or~~
2 ~~customers to or for any performance, show, entertainment, exhibition, or event, or for the purpose of~~
3 ~~demonstrating any such sound equipment.~~

5 **~~SEC. 2901.10. NONCOMMERCIAL PURPOSE.~~**

6 ~~Noncommercial purpose shall mean the use, operation, or maintenance of any sound equipment~~
7 ~~for other than a commercial purpose. "Noncommercial purpose" shall mean and include, but shall not~~
8 ~~be limited to, philanthropic, political, patriotic, and charitable purposes.~~

9
10 **~~SEC. 2901.11. UNNECESSARY, EXCESSIVE, OR OFFENSIVE NOISE.~~**

11 ~~Unnecessary, excessive, or offensive noise shall mean any sound or noise conflicting with the~~
12 ~~criteria, standards, or levels set forth in this Article for permissible noises. In the absence of specific~~
13 ~~maximum noise levels, a noise level which exceeds the ambient noise level by 5 DBA or more, when~~
14 ~~measured at the nearest property line or, in the case of multiple family residential buildings, when~~
15 ~~measured anywhere in one dwelling unit with respect to a noise emanating from another dwelling unit~~
16 ~~or from common space in the same building, shall be deemed a prima facie violation of this Article.~~

17
18 **~~SEC. 2901.12. POWERED CONSTRUCTION EQUIPMENT.~~**

19 ~~Any tools, machinery, or equipment used in connection with construction operations which can~~
20 ~~be driven by energy in any form other than manpower, including all types of motor vehicles when used~~
21 ~~in the construction process of any construction site, regardless of whether such construction site be~~
22 ~~located on highway or off highway, and further including all helicopters or other aircraft when used in~~
23 ~~the construction process except as may be preempted for regulation by State or Federal law.~~

1 **~~SEC. 2901.13. POWERED MODEL VEHICLES.~~**

2 ~~Airborne, waterborne, or landborne vehicles of any kind or size which are not designed for~~
3 ~~carrying persons or property, and which can be driven by energy in any form other than manpower or~~
4 ~~windpower.~~

5
6 **~~SEC. 2901.14. ZONING DISTRICTS.~~**

7 ~~Zoning Districts shall be as defined and described in Part II, Chapter II of the San Francisco~~
8 ~~Municipal Code (City Planning Code).~~

9
10 **SEC. 2902. NOISE LEVEL MEASUREMENT.**

11 A person measuring the outside noise level shall take measurements with the microphone not
12 less than four feet above the ground, at least four and one-half feet distant from walls or similar large
13 reflecting surfaces, and protected from the effects of wind noises and other extraneous sounds by the
14 use of appropriate windscreens. A person measuring the inside noise level measurements shall take
15 measurements with the microphone at least three feet distant from any wall, and the average
16 measurement of at least three microphone positions throughout the room shall be used to determine the
17 inside noise level measurement.

18 ~~For the purpose of enforcement of the provisions of this Article, noise level shall be measured~~
19 ~~on the A weighted scale with a sound level meter satisfying at least the applicable requirements for~~
20 ~~Type 1 sound level meters as defined in American National Standard S1.4 1971 or the most recent~~
21 ~~revisions thereof. The meter shall be set for slow response speed, except that for impulse noises or~~
22 ~~rapidly varying sound levels, fast response speed may be used. Prior to each measurement, the meter~~
23 ~~shall be verified, and adjusted to ±0.3 decibel by means of an acoustical calibrator.~~

1 **~~SEC. 2903. SCHOOLS, HOSPITALS, AND CHURCHES.~~**

2 ~~It shall be unlawful for any person to create any unnecessary, excessive or offensive noise on~~
3 ~~any street, sidewalk, or public place adjacent to any school, institution of learning, or church while any~~
4 ~~of the same is in use, or adjacent to any hospital at any time, provided conspicuous signs are displayed~~
5 ~~in such streets, sidewalk or public place indicating the presence of a school, institution of learning,~~
6 ~~church or hospital.~~

7
8 **SEC. 2904. WASTE DISPOSAL SERVICES.**

9 It shall be unlawful for any person authorized to engage in waste removal, collection, or
10 disposal services or recycling removal or garbage-collection services to provide such services so
11 as to create an unnecessary amount of noise, in the judgment of the Director of Public Health
12 ~~or his authorized representative~~. For the purpose of this Section ~~or Section 2915,~~ noise emitted by
13 equipment shall not be deemed unnecessary or without justification if the person engaged in
14 such services has, to the extent the Director of Public Health has judged reasonably feasible ~~in~~
15 ~~the judgment of the Director~~, incorporated available sound-deadening devices into equipment
16 used in rendering those services.

17 Notwithstanding the foregoing, it shall be unlawful for any person authorized to engage
18 in waste removal, collection, or disposal services, or recycling removal or garbage-collection
19 services to operate hydraulic compaction or mechanical processing systems on any truck-mounted
20 waste, recycling, ~~or~~ garbage loading ~~and/or~~ compacting equipment or similar mechanical
21 device ~~in any manner~~ so as to create mechanical or hydraulic noise any noise exceeding 75 dBA
22 ~~the following levels~~ when measured at a distance of 50 feet from the equipment. This maximum
23 noise level does not apply to the noise associated with crushing, impacting, dropping, or moving

1 garbage on the truck, but only to the truck's mechanical processing system. All other waste disposal or
2 collection noises are subject to the Director of Public Health's judgment as described in this Section.

3 ~~(a) On and after a date six months after the effective date of this Article..... 80 DBA~~

8 **~~SEC. 2906. MOTOR VEHICLES, OFF-HIGHWAY USE.~~**

9 ~~Except as otherwise provided for in this Article, it shall be unlawful to operate any motor~~
10 ~~vehicle of any type on any site not located on a public street or highway as defined in the California~~
11 ~~Vehicle Code, in any manner so as to emit noise in excess of the following levels:~~

12 ~~(a) In Zoning Districts P, when measured at a distance of 50 from the vehicle:~~

13 ~~(1) Any type of motor vehicle with a manufacturer's gross vehicle weight rating of 6,000 pounds~~
14 ~~or more, and any combination of vehicle, as defined in the California Vehicle Code.... 82 DBA.~~

15 ~~(2) Any motorcycle other than a motor driven cycle, as defined in the California Vehicle~~
16 ~~Code.... 77 DBA.~~

17 ~~(3) Any other on highway type motor vehicle except motor driven cycles, as defined in the~~
18 ~~California Vehicle Code, and any combination of vehicles towed by such motor vehicles.... 74 DBA.~~

19 ~~(4) Any off highway type motor vehicle with a manufacturer's gross vehicle weight rating of less~~
20 ~~than 6,000 pounds; and any motor driven cycle, all as defined in the California Vehicle Code, and any~~
21 ~~other motor vehicle which may be exempt from said Code.... 70 DBA.~~

22 ~~Nothing in this Section shall apply to authorized emergency vehicles when being used in~~

1 **SEC. 2907. CONSTRUCTION EQUIPMENT.**

2 ~~(a) Except as provided for in Subsections (c), (d) and (e) hereof, on and after a date six months~~
3 ~~after the effective date of this Article, it shall be unlawful for any person, including the City and County~~
4 ~~of San Francisco, to operate any powered construction equipment, regardless of age or date of~~
5 ~~acquisition, if the operation of such equipment emits noise at a level in excess of 85 DBA when~~
6 ~~measured at a distance of 100 feet from such equipment, or an equivalent sound level at some other~~
7 ~~convenient distance.~~

8 ~~(a) (b)~~ Except as provided for in Subsections ~~(b)~~, (c), ~~and~~ (d) ~~and (e)~~ hereof, ~~on and after~~
9 ~~a date forty two months after the effective date of this Article,~~ it shall be unlawful for any person,
10 ~~including the City and County of San Francisco,~~ to operate any powered construction equipment,
11 ~~regardless of age or date of acquisition,~~ if the operation of such equipment emits noise at a level
12 in excess of 80 dBA when measured at a distance of 100 feet from such equipment, or an
13 equivalent sound level at some other convenient distance.

14 ~~(b) (e)~~ The provisions of Subsections ~~(a) and (b)~~ of this Section shall not be applicable
15 to impact tools and equipment, provided that ~~on and after a date six months after the effective date~~
16 ~~of this Article, that~~ such impact tools and equipment shall have intake and exhaust mufflers
17 recommended by the manufacturers thereof and approved by the Director of Public Works ~~or~~
18 ~~the Director of Building Inspection~~ as best accomplishing maximum noise attenuation, and that
19 pavement breakers and jackhammers shall also be equipped with acoustically attenuating
20 shields or shrouds recommended by the manufacturers thereof and approved by the Director
21 of Public Works ~~or the Director of Building Inspection~~ as best accomplishing maximum noise
22 attenuation. ~~In the absence of manufacturer's recommendations, the Director of Public Works may~~
23 ~~prescribe such means of accomplishing maximum noise attenuation as he deems to be in the public~~
24 ~~interest.~~

1 ~~(c) (d)~~ The provisions of Subsections (a) ~~and (b)~~ of this Section shall not be applicable
2 to construction equipment used in connection with emergency work.

3 ~~(d) (e) For the period ending 24 months after the effective date of this Article, any helicopter or~~
4 ~~other aircraft used in the construction process may exceed the noise limits set forth in Subsections (a)~~
5 ~~and (b) hereof; provided, however, that any such equipment- Helicopters shall not be used for~~
6 ~~construction purposes for more than two hours in any single day or more than four hours in any~~
7 ~~single week, , and provided, further, that such equipment shall not be used at any time within 600 feet~~
8 ~~of any hospital or within 600 feet of any school or other educational institution while the same is being~~
9 ~~used for school purposes or within 600 feet of any church while the same is being used for religious~~
10 ~~purposes.~~

11 ~~On and after a date 24 months after the effective date of this Article, it shall be unlawful for any~~
12 ~~person, including the City and County of San Francisco, to operate a helicopter or other aircraft in the~~
13 ~~construction process, regardless of age or date of acquisition, if the operation of such equipment emits~~
14 ~~noise at a level in excess of 85 dBA when measured at a distance of 100 feet from such equipment, or~~
15 ~~an equivalent sound level at some other convenient distance.~~

16
17 **SEC. 2908. CONSTRUCTION WORK AT NIGHT.**

18 It shall be unlawful for any person, between the hours of 8:00 p.m. of any day and 7:00
19 a.m. of the following day to erect, construct, demolish, excavate for, alter or repair any
20 building or structure if the noise level created thereby is in excess of the ambient noise level
21 by 5 dBA at the nearest property plane line, unless a special permit therefor has been applied
22 for and granted by the Director of Public Works or the Director of Building Inspection. In granting
23 such special permit the Director of Public Works or the Director of Building Inspection shall
24 consider: if construction noise in the vicinity of the proposed work site would be less
25

1 objectionable at night than during daytime because of different population levels or different
2 neighboring activities; if obstruction and interference with traffic, particularly on streets of
3 major importance, would be less objectionable at night than during daytime; if the kind of
4 work to be performed emits noises at such a low level as to not cause significant disturbance
5 in the vicinity of the work site; if the neighborhood of the proposed work site is primarily
6 residential in character wherein sleep could be disturbed; if great economic hardship would
7 occur if the work were spread over a longer time; if the work will abate or prevent hazard to
8 life or property; and if the proposed night work is in the general public interest; ~~and he the~~ The
9 Director of Public Works or the Director of Building Inspection shall prescribe such conditions,
10 working times, types of construction equipment to be used, and permissible noise emissions,
11 as ~~he deems to be~~ required in the public interest.

12 The provisions of this Section shall not be applicable to emergency work ~~provided that~~
13 ~~the Director of Public Works shall be notified of such emergency work forthwith.~~

14

15 **SEC. 2909. ~~FIXED SOURCE NOISE LIMITS LEVEL.~~**

16 **(a) Residential Property Noise Limits.**

17 (1) No person shall produce or allow to be produced by any machine, or device,
18 music or entertainment or any combination of same, on residential property over which the person has
19 ownership or control, a noise level more than five dBA above the ambient at any point outside of the
20 property plane.

21 (2) No person shall produce or allow to be produced by any machine, or device,
22 music or entertainment or any combination of same, on multi-unit residential property over which the
23 person has ownership or control, a noise level more than five dBA above the local ambient three feet
24 from any wall, floor, or ceiling inside any dwelling unit on the same property, when the windows and

25

1 doors of the dwelling unit are closed, except within the dwelling unit in which the noise source or
2 sources may be located.

3 **(b) Commercial And Industrial Property Noise Limits.**

4 No person shall produce or allow to be produced by any machine or device, music or
5 entertainment or any combination of same, on commercial or industrial property over which the person
6 has ownership or control, a noise level more than eight dBA above the local ambient at any point
7 outside of the property plane. With respect to noise generated from a licensed Place of Entertainment,
8 in addition to the above dBA criteria a secondary low frequency dBC criteria shall apply to the
9 definition above. No noise or music associated with a licensed Place of Entertainment shall exceed the
10 low frequency ambient noise level defined in Section 2901(f) by more than 8 dBC.

11 **(c) Public Property Noise Limits.**

12 No person shall produce or allow to be produced by any machine or device, or any combination
13 of same, on public property, a noise level more than ten dBA above the local ambient at a distance of
14 twenty-five feet or more, unless the machine or device is being operated to serve or maintain the
15 property or as otherwise provided in this Article.

16 **(d) Fixed Residential Interior Noise Limits.**

17 In order to prevent sleep disturbance, protect public health and prevent the acoustical
18 environment from progressive deterioration due to the increasing use and influence of mechanical
19 equipment, no fixed noise source may cause the noise level measured inside any sleeping or living room
20 in any dwelling unit located on residential property to exceed 45 dBA between the hours of 10:00 p.m.
21 to 7:00 a.m. or 55 dBA between the hours of 7:00 a.m. to 10:00 p.m. with windows open except where
22 building ventilation is achieved through mechanical systems that allow windows to remain closed.

23 **(e) Noise Caused By Activities Subject To Permits From the City and County of San**
24 **Francisco.**

1 None of the noise limits set forth in this Section apply to activity for which the City and County
 2 of San Francisco has issued a permit that contains noise limit provisions that are different from those
 3 set forth in this Article.

4 ~~(a) Except as provided for in subsection (b) hereof, in Zoning Districts R 1 D, R 1, R 2, R 3, R~~
 5 ~~3.5, R 4, R 5, R 3 C, R 3.5 C, R 4 C and R 5 C, on and after a date six months after the effective date~~
 6 ~~of this article, in Zoning Districts C 1, C 2, C 3 O, C 3 R, C 3 G, C 3 S, and C M, on and after a date~~
 7 ~~twelve months after the effective date of this Article, and in Zoning Districts M 1 and M 2, on and after~~

24 address, maintain, and improve the acoustical quality of the San Francisco environment. The task

1 force shall be comprised of one representative from each of the following City departments: the
2 Department of Public Health, the Department of Public Works, the Department of Building Inspection,
3 the Planning Department, the Police Department, the Entertainment Commission, and Animal Care
4 and Control. The members of the task force shall be appointed by their respective Department
5 Directors.

6 (2) **Non-Voting Members.** The Task Force shall invite other City departments, such
7 as the Fire Department and the Municipal Railway, to send a representative to sit as a non-voting
8 member of the task force with respect to vehicle noise, and community representatives when the
9 Director of Public Health deems necessary additional expertise, resources, or other assistance.

10 (b) **Meetings.** The task force shall meet on a regular basis and exchange information
11 regarding noise abatement matters including but not limited to: motor vehicle noise control,
12 coordination of complaint response, animal noise control, implementation of building codes related to
13 acoustical insulation of new residential construction, oversight of complaints regarding entertainment
14 noise, implementation of General Plan Policies related to noise, environmental review, maintenance
15 and upgrades to noise control ordinance as needed, and coordination of noise abatement activities that
16 involve more than one department. Upon the Director of Public Health's request, the Task Force shall
17 provide consultation services and assistance to the Director of Public Health for the purpose of
18 facilitating coordinated implementation of the duties imposed on the Director of Public Health by this
19 ordinance.

20 (c) **Reporting.** The Director of Public Health shall report to the Board of Supervisors every
21 year for three years with respect to progress and findings of the Task Force and any necessary changes
22 in the Regulation of Noise Ordinance, Article 29, San Francisco Police Code, that may be required to
23 maintain and improve the acoustical environment of San Francisco. At the end of three years, the task
24 force shall sunset unless continued by the Board of Supervisors.

1 ~~If any provision, clause, sentence, or paragraph of this Article, or the application thereof to any~~

6 **SEC. 2920. AUTHORITY TO ADOPT RULES AND REGULATIONS.**

7 The Director of Public Health may issue and amend rules, regulations, standards, guidelines, or
8 conditions to implement and enforce this Article.

9
10 **SEC. 2922. PREEMPTION.**

11 In adopting this Article, the Board of Supervisors does not intend to regulate or affect the rights
12 or authority of the State to do those things that are required, directed, or expressly authorized by
13 Federal or State law. Further, in adopting this Article, the Board of Supervisors does not intend to
14 prohibit that which is prohibited by Federal or State law.

15
16 **SEC. 2924. CITY UNDERTAKING LIMITED TO PROMOTION OF GENERAL WELFARE.**

17 In undertaking the adoption and enforcement of this Article, the City is assuming an
18 undertaking only to promote the general welfare. The City does not intend to impose the type of
19 obligation that would allow a person to sue for money damages for an injury that the person claims to
20 suffer as a result of a City officer or employee taking or failing to take an action with respect to any
21 matter covered by this Article.

22
23 **SEC. 2926. SEVERABILITY.**

1 If any of the provisions of this Article or the application thereof to any person or circumstance
2 is held invalid, the remainder of this Article, including the application of such part or provisions to
3 persons or circumstances other than those to which it is held invalid, shall not be affected thereby and
4 shall continue in full force and effect. To this end, the provisions of this Article are severable.
