11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The Planning Department has determined that the actions contemplated in
13 this ordinance comply with the California Environmental Quality Act (California Public
14 Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the
15 Board of Supervisors in File No. 130285 and is incorporated herein by reference.

16 Section 2. In order to promote Small Business Week and permit sidewalk sales of
17 merchandise, San Francisco Public Works Code, Section 724.1(b), setting a fee for temporary
18 street space occupancy, is hereby waived on Saturday, May 11, 2013, between the hours of 7
19 a.m. and 9 p.m for the following geographic areas of the City and County of San Francisco:

16 a.m. and 9 p.m. for the following geographic areas of the City and County of San Francisco:


