3 **Ordinance authorizing settlement of the lawsuit filed by Kareim McKnight against the**
4 **City and County of San Francisco for \$75,000; the lawsuit was filed on August 9, 2022,**
5 **in United States District Court for the Northern District of California, Case No. 22-cv-**
6 **04600 WHO; entitled Kareim McKnight v. City and County of San Francisco, et al.; the**
7 **lawsuit involves alleged civil rights violations.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kareim McKnight v. City and County of
12 San Francisco, et al., United States District Court for the Northern District of California, Case
13 No. 22-cv-04600 WHO by the payment of \$75,000. The lawsuit involves alleged civil rights
14 violations.

15 Section 2. The above-named action was filed in United States District Court for the
16 Northern District of California on August 9, 2022, and the following parties were named in the
17 lawsuit: Plaintiff Kareim McKnight; Defendants: City and County of San Francisco, Dean
18 Shiraishi, Alonso Duarte Sosa, Thomas Smith, Amy Hurwitz, Ryan Buckley, and Felicia Lee.
