13 Board of Supervisors in File No. 030622 and is incorporated herein by reference.

14 Section 2. The Board of Supervisors approves the following fee schedule for discovery

17 thereafter

18 Reproduction of audiotapes: ~~\$7.50~~ \$9.00

19 Cost of audiotape (if not provided by requestor): \$5.00


20 Reproduction of videotape: ~~\$25.00~~ \$37.50




