2 Compact - Not to Exceed \$267,372]

3 **Resolution authorizing the Office of the District Attorney to accept and expend a**  
4 **grant in the amount of \$89,124 for the period of July 1, 2019, through June 30, 2020;**  
5 **\$89,124 for the period of July 1, 2020, through June 30, 2021; and \$89,124 for the**  
6 **period of July 1, 2021, through June 30, 2022, for a total not to exceed amount of**  
7 **\$267,372 from the California Victim Compensation Board for the grant period of July**  
8 **1, 2019, through June 30, 2022, to continue the Criminal Restitution Compact should**  
9 **the parties agree to an amendment as allowed under the provisions of the grant**  
10 **agreement.**

12 WHEREAS, The City and County of San Francisco desires to enter into an  
13 agreement with the California Victim Compensation Board in accordance with Government  
14 Code, Section 13835 for the purpose of ensuring that restitution fines and orders are  
15 properly administered; and

16 WHEREAS, Funds received shall not be used to supplant local funds that would, in  
17 the absence of California Victim Compensation Board Programs, be made available to  
18 support the assistance of victims and witnesses of crime; and

19 WHEREAS, The Board of Supervisors provided in Section 11.1 of the administrative  
20 provisions of the FY2019-2022 Annual Appropriation Ordinance that approval of recurring  
21 grant funds contained in departmental budget submission and approved in the FY 2019-  
22 2022 budget are deemed to meet the requirements of the Administrative Code regarding  
23 grant approvals; and

1           WHEREAS, The California Victim Compensation Board that provides grant funds to  
2 the Office of the District Attorney requires documentation of the Board's approval of its  
3 Criminal Restitution Compact funds; and

4           WHEREAS, All positions supported by these funds shall be coded "G" in the District  
5 Attorney's budget; and

6           WHEREAS, The District Attorney proposes to maximize use of available grant funds  
7 for program expenditures by not including indirect costs in the grant budget; and


8           WHEREAS, The grant does not require an amendment to the Annual Salary  
9 Ordinance (ASO); now, therefore, be it

10          RESOLVED, That the District Attorney of the City and County of San Francisco, or  
11 his designee, is authorized on behalf of the City and County of San Francisco to contract  
12 for, and accept and expend funds from the California Victim Compensation Board to  
13 continue the Criminal Restitution Compact, including any extensions, augmentations or  
14 amendments thereof; and, be it

15          FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
16 indirect costs in the grant budget.




