3 RESOLUTION URGING THE SAN FRANCISCO PUBLIC UTILITIES COMMISSION AND  
4 THE PACIFIC GAS AND ELECTRIC COMPANY TO PLACE STICKERS WITH THE  
5 CONTACT INFORMATION FOR BULB REPLACEMENT ON STREETLIGHT AS  
6 MAINTENANCE CREWS PERFORM SERVICE AND ON THEIR WEB SITE.

7 WHEREAS, The San Francisco Bureau of Light, Heat and Power  
8 maintains about one half of the approximately 40,000 streetlights  
9 throughout the city and Pacific Gas and Electric Company (PG&E) owns  
10 and provides maintenance service under contract to the City on the  
11 other half of the streetlights; and,

12 WHEREAS, Neither entity routinely surveys their streetlights  
13 for outages and normally bulbs are replaced when citizens report  
14 outages; and,

15 WHEREAS, In response to an inquiry on the feasibility of  
16 indicating on streetlight, by stencil or other means, the appropriate  
17 telephone number of who and where to call when a streetlight needs  
18 service, the PUC stated that stenciling or tagging streetlight poles  
19 presented some major obstacles; and,

20 WHEREAS, In response to that same inquiry the PUC reported that  
21 placing a sticker with the appropriate information on streetlight  
22 poles with suitable surfaces as maintenance crews perform service;  
23 now, therefore, be it

24 RESOLVED, That the Board of Supervisors of the City and County  
25 of San Francisco urges the San Francisco Public Utilities Commission

1 to place stickers with the contact information for bulb replacement  
2 on streetlight poles as maintenance crews perform service and on  
3 their web site; and be it

4 FURTHER RESOLVED, That the Board of Supervisors of the City and  
5 County of San Francisco urges the Pacific Gas and Electric Company to  
6 place stickers with the contact information for bulb replacement on  
7 streetlight poles as maintenance crews perform service and on their  
8 web site, and that a copy of this resolution be forwarded to these  
9 agencies.


