3 **Ordinance authorizing settlement of the lawsuit filed by Christopher Kurrle against the**
4 **City and County of San Francisco for \$50,000; the lawsuit was filed on May 11, 2018, in**
5 **San Francisco Superior Court, Case No. CGC-18-566499; entitled Christopher Kurrle v.**
6 **City and County of San Francisco; the lawsuit involves alleged personal injury in**
7 **connection with a bicycle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Christopher Kurrle v. City and County
12 of San Francisco, San Francisco Superior Court, Case No. CGC-18-566499 by the payment
13 of \$50,000. The lawsuit involves alleged personal injury in connection with a bicyclist collision
14 with a metal gate in a City park.

16 Section 2. The above-named action was filed in San Francisco Superior Court on May
17 11, 2018, and the following parties were named in the lawsuit: Christopher Kurrle, Plaintiff,
