6 was November 27, 1978; and,

7 WHEREAS, Keith Grand is the first and only Risk Manager of the
8 City and County of San Francisco; and,

9 WHEREAS, San Francisco is largely self insured, Keith focused on
10 education, training, accountability, risk transfer, alternative
11 funding and legislative measures; and,

12 WHEREAS, Keith created the risk management program for San
13 Francisco's highly decentralized, 27,000 employee, \$4 billion annual
14 budget organization; and,

15 WHEREAS, Keith created a cost allocation system for internal
16 budgetary accountability as well as developed a contract insurance
17 manual that won a national PRIMA award; and,

18 WHEREAS, Keith developed a surety bonding program to facilitate
19 small contractors' ability to secure City contracts; and,

20 WHEREAS, He also developed and conducted workshops for community
21 small business and non-profit organizations around insurance and risk
22 management concerns; and,

23 WHEREAS, Keith has decided to leave his job as the City's Risk
24 Manager and take a job with AON Risk Services; and,

1 WHEREAS, Keith's contributions and successes as Risk Manager
2 will continue to benefit the City for years to come; and now,

4 RESOLVED, That the San Francisco Board of Supervisors commends
5 Keith Grand on the eve of his departure for the hard work and


