Eno St. Francis, LLC has filed an application with the California Department of Alcoholic Beverage Control (ABC) seeking a Type 42 (On-Sale Beer and Wine Public Premises) license for 310-320 Geary Street (located on the North side of Geary street between Powell and Mason).

This electronic surveillance shall be utilized during operating hours. Said electronic recording shall be kept at least 30 days and shall be made available to the Department and Police Department upon demand.

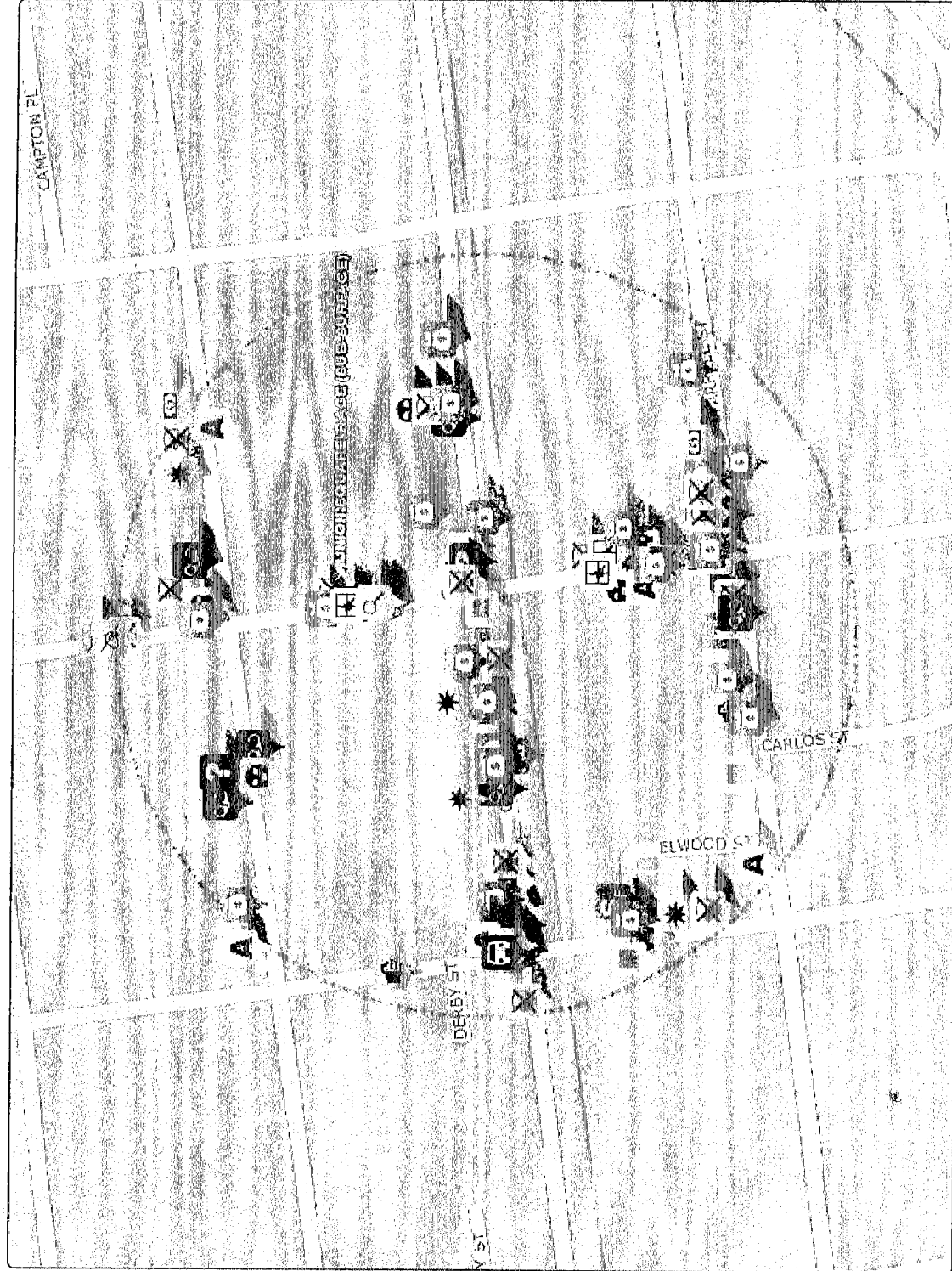

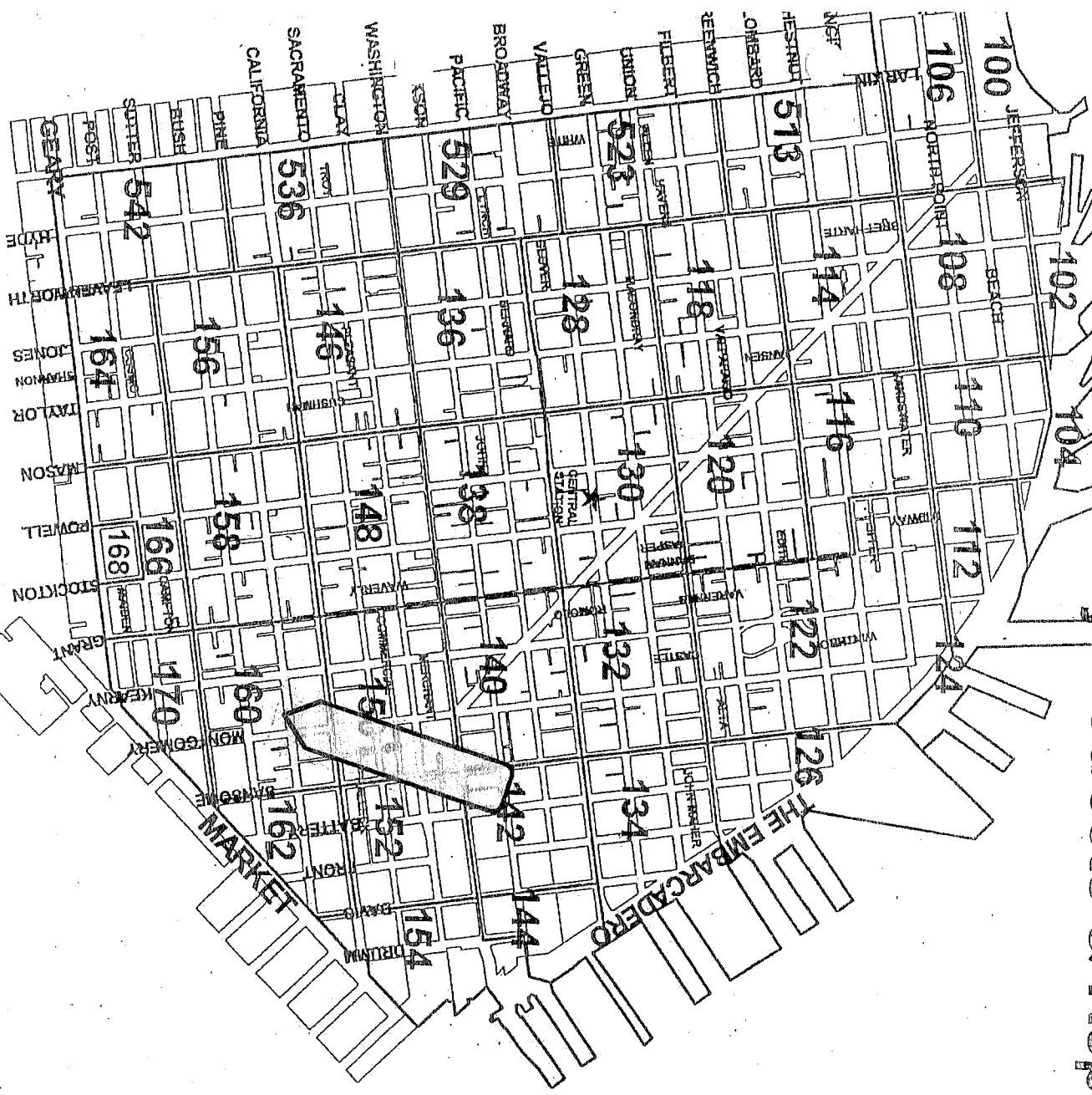



Dear Ms. Calvillo,

Eno St. Francis, LLC, which will do business as "Eno," has applied to the Department of Alcoholic Beverage Control for a Type 42 On-Sale Beer and Wine Public Premises license at the address listed above. The premises are on the southern side of the St. Francis Hotel, accessible from Geary only, not through the hotel. Because the new wine bar is located in a census tract that has an "undue concentration" of on-sale licenses under Section 23958.4 of the Business and Professions Code and because the type 42 wine bar license is a "public premises" license for a venue which will not allow persons under 21 to enter, Eno is requesting a determination by the Board of Supervisors that public convenience or necessity will be served by issuance of the license.

Eno intends to offer international wines by the glass and in structured tasting flights, along with a broad selection of cheeses and chocolates. While the selections will certainly feature local wines, cheeses and chocolates, the focus will be on an international array of choices. The new wine bar will be designed specifically to meet the needs of urban residents, city shoppers and visitors to the city and the hotel from around the world. It is close to the theatre district and shopping and will offer a warm and unpretentious atmosphere in which patrons can indulge in glasses and tastes of wine and pairings of various cheeses and chocolate. It will be a convenient stop for persons finishing their day's activities or beginning their evenings. The intended hours of operation are from 10:00 AM until midnight so that patrons can stop by after theatre performances or other cultural events.

Eno has designed its premises to be more intimate and quiet than nearby bars and restaurants. Its focus on cheese and chocolate with its wines is unique to the Union Square area and is intended to appeal to a broad spectrum of patrons. There are other Eno wine bars in California and other states, and Eno expects to serve patrons who have experienced the wine, cheese and chocolate in these other venues and welcome the opportunity to visit Eno again in a new locale.
