7	parking of vehicles are hereby enacted or rescinded as designated below:

9	RESIDENTIAL PERMIT PARKING AREA "J" (TWO-HOUR TIME LIMIT, 8 AM - 5 PM, MONDAY THROUGH FRIDAY) - ESTABLISH

11	Waller Street, both sides, between Belvedere and Cole Streets.
12	RESIDENTIAL PERMIT PARKING AREA "Z" (TWO-HOUR TIME LIMIT, 8 AM - 6 PM MONDAY THROUGH FRIDAY) - ESTABLISH
13	3301-3303 Mission Street, between Fair and Virginia Avenues (adds specified
14	addresses only).
15	TOW-AWAY, NO STOPPING, 7 AM TO 9 AM, MONDAY THROUGH FRIDAY

7	(accommodating seven motorcycle spaces).
8	PARKING METER AREA NO. 3 (1-HOUR TIME LIMIT, 9 AM - 6 PM, MONDAY
9	THROUGH SATURDAY) - ESTABLISH
10	Stillman Street, north side, between 3rd and 4th Streets.
11	
12	Categorically exempt from Environmenta Review Class 1(c)(9) changes in the traffic
13	and parking regulations where such changes do not establish a higher speed
14	limit or result in more than a negligible increase in the use of the street.
