13 No. 220319 and is incorporated herein by reference; and

14 WHEREAS, Public Works, in a decision dated March 18, 2022, approved a Tentative  
15 Map for a two-lot subdivision project at 2556 Filbert Street, Assessor's Parcel Block No. 0944,  
16 Lot Nos. 025 and 026; and

17 WHEREAS, Said determination is on file with the Clerk of the Board of Supervisors in  
18 File No. 220319 and is incorporated herein by reference; and

19 WHEREAS, On March 28, 2022, Roberta Holden filed a timely appeal of the decision  
20 of Public Works; and

21 WHEREAS, On April 26, 2022, this Board held a duly noticed public hearing to  
22 consider the appeal of Public Works' decision regarding the Tentative Map filed by Appellant;

1           WHEREAS, This Board has reviewed and considered the subject Tentative Map, the  
2 appeal letter, and the other written records before the Board of Supervisors, and heard  
3 testimony and received public comment regarding the subject Tentative Map; now, therefore,  
4 be it

5           MOVED, That the Board hereby adopts as its own the Planning Commission's  
6 environmental findings and findings of consistency with the General Plan, and Planning Code,  
7 Section 101.1, concerning a Tentative Map for the project at Assessor's Parcel Block No.  
8 0944, Lot Nos. 025 and 026; and, be it

9           FURTHER MOVED, That the Board approves the decision of Public Works concerning  
10 the Tentative Map and hereby approves said Map.
