8 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by adding
11 Section 4.24, to read as follows:

12 **SEC. 4.24. PARKING FEE FOR CITY PARKING FACILITIES.**

13 Where the City provides parking to City employees or to City tenants at facilities under the
14 City's management or control, the City may charge the following monthly fee for parking to those
15 employees or tenants:

16 The price of a Municipal Railway monthly pass plus \$10.00, or the existing amount being
17 charged as of May 31, 2004, whichever is higher.

18 This section shall not apply to parking facilities under the management or control of the San
19 Francisco Parking Authority, the Airport, or the Port.

20
21 Section 2. The Planning Department has determined that the actions contemplated in
22 this Ordinance are in compliance with the California Environmental Quality Act (California
23 Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk


