8	Francisco (CCSF) are Lead Agencies preparing the environmental impact reports for the
9	proposed runway reconfiguration project (Project) at the San Francisco International Airport
10	(SFO); and,
11	WHEREAS, The Lead Agencies entered into a Memorandum of Understanding (MOU)
12	in June of 1999 to cooperate in the parallel preparation of an Environmental Impact Report
13	(EIR) and an Environmental Impact Statement (EIS) for the Project; and,
14	WHEREAS, The Lead Agencies developed a selection process to hire a contractor to
15	prepare the EIR, EIS and technical studies to be used in the EIR and EIS and established a
16	selection panel including the Lead Agencies and SFO; and,
17	WHEREAS, The Lead Agencies, through the established selection process, selected
18	the URS Corporation as the contractor to complete these environmental documents and
19	studies and that consultant, URS Corporation, has provided associated scopes of services
20	and cost estimates; and,
21	WHEREAS, The Airport Commission, subject to the approval of the Board of
22	Supervisors, approved Modification Nos. 4 and 5 to Contract No. 4240.1 with URS
23	Corporation in amounts of \$2,650,000 and \$5,291,558, respectively, for a total modification of
24	\$7,941,558 and a total contract amount not to exceed \$19,741,558; and,
