WHEREAS, The Civil Grand Jury has requested that the Board of Supervisors respond to Finding Nos. 5 and 6 as well as Recommendation Nos. 6 and 7 contained in the subject

WHEREAS, Finding No. 5 states: "Governor Brown's announcement earlier this year that he intends to cut funding to redevelopment agencies in the next fiscal year directly

threatens the Hunters Point Shipyard (HPS) redevelopment project. Up to now, there has been no indication from either the City or the San Francisco Redevelopment Agency (SFRA) how they intend to continue the HPS redevelopment project should redevelopment funds actually be cut or eliminated by the State;" and

WHEREAS, Recommendation No. 6 states: "The City and the SFRA should have contingency plans in place for continuing SFRA related projects, including the HPS redevelopment project, in the event that State redevelopment funds are cut or eliminated;" and

WHEREAS, Finding No. 6 states: "Previous efforts by the City to implement work force policies at city-funded construction projects such as the HPS redevelopment project have largely proved ineffective as they only require a contractor to make a good faith effort to hire local workers. Earlier this year a new work force ordinance came into effect that has stricter requirements and mandates;" and

WHEREAS, Recommendation No. 7 states: "In order to ensure that the job creation goals promised for the HPS redevelopment project are realized, the City should insure that the Office of Labor Standards Enforcement has sufficient resources to allow it to effectively enforce the provisions of the new workforce laws;" and

WHEREAS, in accordance with Penal Code Section 933.05(c), the Board of Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior Court on Finding Nos. 5 and 6, as well as Recommendation Nos. 6 and 7 contained in the subject Civil Grand Jury report; now, therefore, be it

RESOLVED, That the Board of Supervisors reports to the Presiding Judge of the Superior Court that it disagrees with Finding Nos. 5 and 6; and be it

FURTHER RESOLVED, That the Board of Supervisors reports that it agrees with Recommendation No. 7; and be it

FURTHER RESOLVED, That the Board of Supervisors urges the Mayor to cause the implementation of accepted findings and recommendations through his/her department heads and through the development of the annual budget.
