3 **Resolution authorizing the Director of Transportation or his designee to retroactively**
4 **~~apply for,~~ accept and expend \$112,000 in FY 02/03 Transportation Fund for Clean Air**
5 **(TFCA) from the Bay Area Air Quality Management District (Air District) to stripe and**
6 **sign bike lanes on Cabrillo Street and to execute any and all associated documents.**

8 WHEREAS, Assembly Bill 434 created the Transportation Fund for Clean Air in the Bay
9 Area, and provided authority to the Air District to impose up to a \$4.00 surcharge on motor
10 vehicle registration fees within its jurisdiction, to be used to implement specified transportation
11 control measures; and

12 WHEREAS, On October 16, 1991, the Air District approved a \$2.00 surcharge on
13 motor vehicle registration fees, and raised the surcharge to \$4.00 effective April 1, 1993; and

14 WHEREAS, The City and County of San Francisco supports the Bay Area Clean Air
15 Plan; and

16 WHEREAS, The Department of Parking and Traffic's Bicycle Program has identified a
17 \$140,000 project to stripe bike lanes on Cabrillo Street (Arguello Boulevard to La Playa
18 Street); and

19 WHEREAS The Department of Parking and Traffic Bicycle Program has identified
20 \$28,000 in San Francisco County Transportation Authority Measure B half-cent sales tax
21 Bicycle, Pedestrian, Elderly and Disabled Access Projects (Category 47c) that will be
22 requested as the local match; and

23 WHEREAS, The Board of Supervisors approved Resolution No. 503-02 on July 29,
24 2002 authorizing the City Administrator to apply for a grant in the amount of \$1.15 million from

1 the Bay Area Air Quality Management District for the purpose of implementing programs to
2 improve air quality, including the project to stripe bike lanes on Cabrillo Street; and

3 WHEREAS, The Municipal Transportation Agency Board of Directors approved
4 Resolution No. 02-148 on December 3, 2002 authorizing the Director of Transportation or his
5 designee to accept and expend \$112,000 in FY 02/03 Transportation Fund for Clean Air
6 (TFCA) from the Bay Area Air Quality Management District to stripe and sign bike lanes on
7 Cabrillo Street and to execute any and all associated documents; and

8 WHEREAS, Calculating and claiming indirect costs using the methodology required by
9 the Air District would require additional expense and reduce the funds available for program
10 delivery; therefore be it

11 RESOLVED, that the Board of Supervisors hereby authorize the Director of
12 Transportation or his designee to accept and expend \$112,000 in FY 02/03 Transportation
13 Fund for Clean Air (TFCA) from the Bay Area Air Quality Management District to stripe and
14 sign bike lanes on Cabrillo Street, waving indirect costs, and to execute any and all
15 associated documents.




